6 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HONORING 8 ARKANSAS' WAR HEROES. The appropriation authorized in this Act for Honoring 9 Arkansas' War Heroes is not intended to be carried forward into the base 10 level for the purposes of budget preparation. Any appropriation request for 11 this purpose shall be considered a new appropriation request, and therefore 12 will be considered a change level budget request.

Notwithstanding any law pertaining to the transfer of year-end fund balances or any law to the contrary, any funds provided to the Educational Television Fund Account for the purpose of funding the Honoring Arkansas' War Heroes Appropriation which remain in the Education Television Fund Account at the end of a fiscal year shall remain in the Educational Television Fund Account and shall continue to be allocated to the Honoring Arkansas' War Heroes Appropriation in the following fiscal year.

21 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 22 by this act shall be limited to the appropriation for such agency and funds 23 made available by law for the support of such appropriations; and the 24 restrictions of the State Procurement Law, the General Accounting and 25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 26 Procedures and Restrictions Act, or their successors, and other fiscal 27 control laws of this State, where applicable, and regulations promulgated by 28 the Department of Finance and Administration, as authorized by law, shall be 29 strictly complied with in disbursement of said funds.

30

31 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly 32 that any funds disbursed under the authority of the appropriations contained 33 in this act shall be in compliance with the stated reasons for which this act 34 was adopted, as evidenced by the Agency Requests, Executive Recommendations 35 and Legislative Recommendations contained in the budget manuals prepared by 36 the Department of Finance and Administration, letters, or summarized oral

testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. SECTION 11. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2010 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2010 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2010.
