ADDITIONAL TEACHING LOAD. Instructional staff in a postsecondary technical institute, as authorized for the various technical institutes, may be paid up to forty five dollars (\$45) fifty dollars (\$50) per clock hour for the fiscal year ending June 30, 2010 2011 for non-credit teaching assignments; or, up to five hundred fifty dollars (\$500) (\$550) per semester hour for the fiscal year ending June 30, 2010 2011, for teaching courses beyond the defined teaching load; and the employee's maximum allowable salary may be exceeded by such amount; provided, however, that such additional teaching load may not exceed one hundred fifty (150) clock hours or nine (9) semester credit hours per school year.
