21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. REAPPROPRIATION - DEPARTMENT OF EDUCATION - ENHANCED COMMUNITY  
24 GRANTS - LIBRARIES. There is hereby appropriated, to the Department of  
25 Education, to be payable from the General Improvement Fund or its successor  
26 fund or fund accounts, for the Department of Education, the following:

27 (A) Effective July 1, 2010, the balance of the appropriation provided in  
28 Item (A) of Section 1 of Act 117 of 2009, for Enhanced Community Grants for  
29 Libraries, in a sum not to exceed .....\$20,000.  
30

31 SECTION 2. REAPPROPRIATION - DEPARTMENT OF EDUCATION - AFTER SCHOOL  
32 PROGRAMS. There is hereby appropriated, to the Department of Education, to be  
33 payable from the General Improvement Fund or its successor fund or fund  
34 accounts, for the Department of Education, the following:

35 (A) Effective July 1, 2010, the balance of the appropriation provided in  
36 Item (A) of Section 2 of Act 117 of 2009, for state assistance to after-



1 school programs, in a sum not to exceed .....\$40,000.

20 FAIR ASSOCIATION GRANT. There is hereby appropriated, to the Department of  
21 Education, to be payable from the General Improvement Fund or its successor  
22 fund or fund accounts, for the Department of Education, the following:

23 (A) Effective July 1, 2010, the balance of the appropriation provided in  
24 Item (A) of Section 1 of Act 1065 of 2009, for a grant to the Arkansas  
25 Science Fair Association for personal services, operating expenses,  
26 scholarships, prizes and the purchase of equipment for Arkansas regional  
27 and/or state science fairs, in a sum not to exceed .....\$25,000.

28  
29 SECTION 6. REAPPROPRIATION - DEPARTMENT OF EDUCATION - GENERAL

 17 SECTION 8. REAPPROPRIATION - DIVISION OF PUBLIC SCHOOL ACADEMIC FACILITIES  
 18 AND TRANSPORTATION - SCHOOL BUS SAFETY. There is hereby appropriated, to the

 20 Transportation, to be payable from the General Improvement Fund or its

 25 expenses, and purchase of equipment for a School Bus Safety Equipment Grant  
 26 Pilot Program, in a sum not to exceed .....\$300,000.

 6 based on free and reduced lunch statistics, in a sum not to exceed

 24 construction, improvements, equipment, renovation, and maintenance expenses  
 25 for Arkansas Education Service Cooperatives' facilities for the fiscal year  
 26 ending June 30, 2010, the sum of.....\$20,000.

28 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING -  
 30 ARKANSAS EDUCATION SERVICE COOPERATIVES. As referenced in Section 3 of Act  
 31 1442 of 2009 and Section 3 of Act 1443 of 2009, the authorized funding for  
 32 the Department of Education for a grant for improvements to facilities of the  
 33 Arkansas River Education Services Cooperative shall instead be deemed for  
 34 grants to Arkansas Education Service Cooperatives for operating,  
 35 construction, improvements, equipment, renovation, and maintenance expenses  
 36 for Arkansas Education Service Cooperatives' facilities.

2 SECTION 29. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND  
4 TRANSFER - ARKANSAS EDUCATION SERVICE COOPERATIVES/BOREHAM LIBRARY.

5 Immediately upon the effective date of this Section, the Chief Fiscal Officer  
6 of the State shall transfer on his or her books and those of the State  
7 Treasurer and the Auditor of the State the sum of nine thousand seven hundred  
8 and fifty dollars (\$9,750) from funds deposited into the 87th Session  
9 Projects Account of the General Improvement Fund for the Department of  
10 Education for grants to Arkansas Education Service Cooperatives for  
11 operating, construction, improvements, equipment, renovation, and maintenance  
12 expenses for Arkansas Education Service Cooperatives' facilities to the 87th

28 upgrade, renovation, furnishings, equipment, and expansion of the Boreham  
29 Library.

30  
31 *SECTION 30. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE*  
32 *NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. The*  
33 *reappropriation authorized for statewide grants to public libraries in this*  
34 *Act shall not be restricted by requirements that may be applicable to other*  
35 *programs currently administered. New rules and regulations may be adopted to*  
36 *carry out the intent of the General Assembly regarding the appropriations*

1 authorized in this Act.

2 No less than thirty (30) days prior to the distribution of any funds  
3 appropriated by this act, the director of the agency shall notify the Speaker  
4 of the House of Representatives of the name and address of each recipient and  
5 the amount that is being distributed to each recipient.

6 The grants to public libraries authorized by this act shall be  
7 distributed on a per capita basis and include public libraries that do not  
8 meet the guidelines for State Aid to Public Libraries.

9 The appropriations authorized by this Act and funded through Acts 1442  
10 and 1443 of 2009 to be distributed for the fiscal year ending June 30, 2011  
11 for statewide grants to public libraries shall be distributed directly to the  
12 local libraries independent of the regional system of which they may be a  
13 member.

14  
15 SECTION 31. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
16 obligations otherwise incurred in relation to the project or projects  
17 described herein in excess of the State Treasury funds actually available  
18 therefor as provided by law. Provided, however, that institutions and  
19 agencies listed herein shall have the authority to accept and use grants and  
20 donations including Federal funds, and to use its unobligated cash income or  
21 funds, or both available to it, for the purpose of supplementing the State  
22 Treasury funds for financing the entire costs of the project or projects  
23 enumerated herein. Provided further, that the appropriations and funds  
24 otherwise provided by the General Assembly for Maintenance and General  
25 Operations of the agency or institutions receiving appropriation herein shall  
26 not be used for any of the purposes as appropriated in this act.

27 (B) The restrictions of any applicable provisions of the State Purchasing  
28 Law, the General Accounting and Budgetary Procedures Law, the Revenue  
29 Stabilization Law and any other applicable fiscal control laws of this State  
30 and regulations promulgated by the Department of Finance and Administration,  
31 as authorized by law, shall be strictly complied with in disbursement of any  
32 funds provided by this act unless specifically provided otherwise by law.

33  
34 SECTION 32. LEGISLATIVE INTENT. It is the intent of the General Assembly  
35 that any funds disbursed under the authority of the appropriations contained  
36 in this act shall be in compliance with the stated reasons for which this act

1 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
2 and Legislative Recommendations contained in the budget manuals prepared by  
3 the Department of Finance and Administration, letters, or summarized oral  
4 testimony in the official minutes of the Arkansas Legislative Council or  
5 Joint Budget Committee which relate to its passage and adoption.

6  
7 SECTION 33. EMERGENCY CLAUSE. It is found and determined by the General  
8 Assembly, that the Constitution of the State of Arkansas prohibits the  
9 appropriation of funds for a longer period than one (1) fiscal year; that the  
10 effectiveness of this Act on July 1, 2010 is essential to the operation of  
11 the agency for which the appropriations in this Act are provided, with the  
12 exception that Sections 27, 28 and 29 in this Act which shall be in full  
13 force and effect from and after the date of its passage and approval, and  
14 that in the event of an extension of the legislative session, the delay in  
15 the effective date of this Act beyond July 1, 2010 could work irreparable  
16 harm upon the proper administration and provision of essential governmental  
17 programs, with the exception that Sections 27, 28 and 29 in this Act which  
18 shall be in full force and effect from and after the date of its passage and  
19 approval. Therefore, an emergency is hereby declared to exist and this Act  
20 being necessary for the immediate preservation of the public peace, health  
21 and safety shall be in full force and effect from and after July 1, 2010,  
22 with the exception that Sections 27, 28 and 29 in this Act which shall be in  
23 full force and effect from and after the date of its passage and approval.
