restrictions of the State Procurement Law, the General Accounting and
Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
Procedures and Restrictions Act, or their successors, and other fiscal
control laws of this State, where applicable, and regulations promulgated by
the Department of Finance and Administration, as authorized by law, shall be
strictly complied with in disbursement of said funds.

8 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly 9 that any funds disbursed under the authority of the appropriations contained 10 in this act shall be in compliance with the stated reasons for which this act 11 was adopted, as evidenced by the Agency Requests, Executive Recommendations 12 and Legislative Recommendations contained in the budget manuals prepared by 13 the Department of Finance and Administration, letters, or summarized oral 14 testimony in the official minutes of the Arkansas Legislative Council or 15 Joint Budget Committee which relate to its passage and adoption.

17 SECTION 4. EMERGENCY CLAUSE. It is hereby found and determined by the General Assembly, that funds provided by the General Assembly for the 18 operations of the Department of Arkansas State Police are, due to unforeseen 19 circumstances, insufficient for the Department of Arkansas State Police to 20 21 continue to provide essential governmental services; that the provisions of 22 this act will provide the necessary monies for the Department of Arkansas 23 State Police to continue such services; and that a delay in the effective 24 date of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is 25 26 hereby declared to exist and this Act being necessary for the immediate 27 preservation of the public peace, health and safety shall be in full force 28 and effect from and after the date of its passage and approval. 29 If the bill is neither approved nor vetoed by the Governor, it shall become 30 effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is 31 32 overridden, it shall become effective on the date the last house overrides 33 the veto. 34 35 36
