8 **HOUSE CONCURRENT RESOLUTION**

9 TO PROVIDE THAT THE FISCAL SESSION OF THE EIGHTY-
10 SEVENTH GENERAL ASSEMBLY WILL ADJOURN SINE DIE AT
11 12:00 NOON, ON MARCH 9, 2010 OR AT AN EARLIER
12 DATE AGREED TO BY THE HOUSE OF REPRESENTATIVES
13 AND SENATE; TO PROVIDE FOR A RECESS AT THE CLOSE
14 OF BUSINESS IN EACH CHAMBER ON MARCH 2, 2010; TO
15 AUTHORIZE THE GENERAL ASSEMBLY TO RECONVENE FROM
16 THE RECESS AT ANY TIME BEFORE 12:00 NOON,
17 MARCH 9, 2010, FOR THE PURPOSE OF CONSIDERING
18 VETOES AND CORRECTING ERRORS AND OVERSIGHTS; AND
19 TO AUTHORIZE ADDITIONAL RECESSES OF EITHER OR
20 BOTH CHAMBERS FOR PERIODS OF FOUR (4) CONSECUTIVE
21 DAYS OR LONGER.

23 TO PROVIDE FOR THE DATE OF THE SINE DIE
24 ADJOURNMENT OF THE FISCAL SESSION OF THE
25 EIGHTY-SEVENTH GENERAL ASSEMBLY AND TO
26 PROVIDE FOR RECESSES OF THE HOUSE OF
27 REPRESENTATIVES AND THE SENATE.

32 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-SEVENTH GENERAL
33 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

35 (a) That the Fiscal Session of the Eighty-Seventh General Assembly of
36 the State of Arkansas adjourn sine die at 12:00 noon, March 9, 2010 or at an



1 earlier date as may be agreed to by the House of Representative and Senate.

2 (b)(1) That the Fiscal Session of the Eighty-Seventh General Assembly
3 of the State of Arkansas shall enter into recess at the close of business in
4 each chamber on March 2, 2010, or at an earlier time as may be agreed upon by
5 the House of Representatives and the Senate.

6 (2) That under Arkansas Constitution, Article 6, § 15, prior to
7 adjournment of the General Assembly, the Governor is afforded five days after
8 receipt of a bill to sign a bill or veto a bill, therefore from March 2, 2010
9 through March 9, 2010, the House Representatives and the Senate shall be open
10 so the office of the Chief Clerk of the House of Representatives and the
11 office of the Secretary of the Senate may receive communications, vetoes of
12 bills by the Governor, and notification of errors and oversights.

13 (3) That the Speaker of the House of Representatives and the
14 President Pro Tempore of the Senate may, by joint proclamation, reconvene the
15 General Assembly at any time before 12:00 noon, March 9, 2010, for the
16 purpose of:

17 (A) Considering vetoes; and

18 (B) Correcting errors and oversights.

19 (c) That during the Fiscal Session, in addition to the recess provided
20 for in subdivision (b)(1):

21 (1) The House of Representatives may recess for periods of
22 four (4) consecutive days or longer, by declaration of the Speaker of the
23 House; and

24 (2) The Senate may recess for periods of four (4) consecutive
25 days or longer, by declaration of the President Pro Tempore.
