CLAIMS 5 AWARD REPORTING. It is the intent of the General Assembly that when any 6 state agency, board, commission or institution of higher education admits 7 liability to a claim filed with the State Claims Commission and the claim 8 involves a contract with a state agency, board, commission or institution of 9 higher education or the claim exceeds ten thousand dollars (\$10,000) that 10 such agency, board, commission or institution of higher education file a 11 written report thereof to the Litigation Subcommittee of the Legislative 12 Council. Such a report shall include a concise statement of facts with an explanation of the agency's liability. Provided further, such report shall be 13 14 filed with the Litigation Subcommittee within thirty (30) days after the 15 claim has been adjudicated by the State Claims Commission. 16 SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 17 18 by this act shall be limited to the appropriation for such agency and funds 19 made available by law for the support of such appropriations; and the 20 restrictions of the State Procurement Law, the General Accounting and 21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 22 Procedures and Restrictions Act, or their successors, and other fiscal 23 control laws of this State, where applicable, and regulations promulgated by 24 the Department of Finance and Administration, as authorized by law, shall be 25 strictly complied with in disbursement of said funds. 26 27 SECTION 25. LEGISLATIVE INTENT. It is the intent of the General Assembly 28 that any funds disbursed under the authority of the appropriations contained 29 in this act shall be in compliance with the stated reasons for which this act 30 was adopted, as evidenced by the Agency Requests, Executive Recommendations 31 and Legislative Recommendations contained in the budget manuals prepared by 32 the Department of Finance and Administration, letters, or summarized oral

SECTION 26. EMERGENCY CLAUSE. It is found and determined by the General

testimony in the official minutes of the Arkansas Legislative Council or

Joint Budget Committee which relate to its passage and adoption.

Assembly, that payees listed in this Act may be entitled to the sums appropriated and transferred to herein, and that they have been deprived of the use of these funds for a long period of time, and that further delay in paying these just debts of the State would do harm to the reputation of the State of Arkansas. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval. If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is overridden, it shall become effective on the date the last house overrides the veto.
