12 REINVESTMENT ACT FOR CONSTRUCTION, PERSONAL
13 SERVICES, MAINTENANCE AND OPERATIONS FOR THE
14 FISCAL YEAR ENDING JUNE 30,2011; AND FOR OTHER
15 PURPOSES.

27 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
28

29 SECTION 1. APPROPRIATION - ARKANSAS SCHOOL FOR MATHEMATICS, SCIENCES AND
30 ARTS. There is hereby appropriated, to the University of Arkansas, to be
31 payable from the federal funds as designated by the Chief Fiscal Officer of
32 the State, as provided by the American Recovery and Reinvestment Act, for
33 construction, renovation, furnishings, personal services, maintenance and
34 operation expenses, of the University of Arkansas - Arkansas School for
35 Mathematics, Sciences and Arts for the fiscal year ending June 30, 2011, the
36 sum of\$90,000,000.

2 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
3 by this act shall be limited to the appropriation for such agency and funds
4 made available by law for the support of such appropriations; and the
5 restrictions of the State Procurement Law, the General Accounting and
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
7 Procedures and Restrictions Act, the Higher Education Expenditures
8 Restrictions Act, or their successors, and other fiscal control laws of this
9 State, where applicable, and regulations promulgated by the Department of
10 Finance and Administration, as authorized by law, shall be strictly complied
11 with in disbursement of said funds.

13 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
14 that any funds disbursed under the authority of the appropriations contained
15 in this act shall be in compliance with the stated reasons for which this act
16 was adopted, as evidenced by the Agency Requests, Executive Recommendations
17 and Legislative Recommendations contained in the budget manuals prepared by
18 the Department of Finance and Administration, letters, or summarized oral
19 testimony in the official minutes of the Arkansas Legislative Council or
20 Joint Budget Committee which relate to its passage and adoption.

22 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
23 Assembly, that the Constitution of the State of Arkansas prohibits the
24 appropriation of funds for more than a one (1) year period; that the
25 effectiveness of this Act on July 1, 2010 is essential to the operation of
26 the agency for which the appropriations in this Act are provided, and that in
27 the event of an extension of the legislative session, the delay in the
28 effective date of this Act beyond July 1, 2010 could work irreparable harm
29 upon the proper administration and provision of essential governmental
30 programs. Therefore, an emergency is hereby declared to exist and this Act
31 being necessary for the immediate preservation of the public peace, health
32 and safety shall be in full force and effect from and after July 1, 2010.
