17	to assist in programs carried out or administered by that department.
18	(b) Each department which that utilizes the services of volunteers
19	may:
20	(1) Enlist the services of the Division of $\frac{Volunteerism\ in}{Volunteerism\ in}$
21	Community Service and Nonprofit Support of the Department of Human Services
22	to assist in the development of volunteer programs;
23	(2) Take actions as are necessary and appropriate to develop
24	meaningful opportunities for volunteers involved in those programs and to
25	improve public services;
26	(3) Develop written rules governing recruitment, training,
27	screening, responsibility, utilization, and supervision of volunteers;
28	(4) Take action as is necessary to ensure that volunteer and
29	paid staff of the department understand their respective duties and
30	responsibilities, their relationship to each other, and their respective
31	roles in fulfilling the objectives of their department;
32	(5) Take actions as are necessary and appropriate to assure a
33	receptive climate to attract citizen volunteers; and
34	(6) Provide for the recognition of volunteers who have offered
35	exceptional service to the state, its political subdivisions, or school
