20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Arkansas Crime Information Center for the 2011-2012 fiscal year, the
24 following maximum number of regular employees.

 31 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USE OF
 33 CONTINGENCY APPROPRIATION AND FUNDING. In the event additional appropriation
 34 becomes necessary that is not authorized or contemplated in Section 2 of this
 35 Act and circumstances make it necessary for the Arkansas Crime Information
 36 Center to request additional appropriation to carry out the objectives of the

1 Agency, the Contingency Appropriation authorized herein may be used for
2 regular salaries, personal services matching and maintenance and general
3 operation line item appropriations authorized for such programs in this Act.
4 Funding for the Contingency Appropriation authorized herein may be
5 transferred to the appropriate fund or fund account from such excess funds as
6 the Director of the Arkansas Crime Information Center may determine are
7 available from criminal background check fees deposited on behalf of the
8 Arkansas Crime Information Center. Use of the contingency appropriation and
9 funding authorized in this Act shall be approved by the Chief Fiscal Officer
10 of the State and the Arkansas Legislative Council or Joint Budget Committee.

11 Determining the maximum number of employees and the maximum amount of
12 appropriation and general revenue funding for a state agency each fiscal year
13 is the prerogative of the General Assembly. This is usually accomplished by
14 delineating such maximums in the appropriation act(s) for a state agency and
15 the general revenue allocations authorized for each fund and fund account by
16 amendment to the Revenue Stabilization law. Further, the General Assembly
17 has determined that the Arkansas Crime Information Center may operate more
18 efficiently if some flexibility is provided to the Arkansas Crime Information
19 Center authorizing broad powers under this Section. Therefore, it is both
20 necessary and appropriate that the General Assembly maintain oversight by
21 requiring prior approval of the Legislative Council or Joint Budget Committee
22 as provided by this section. The requirement of approval by the Legislative
23 Council or Joint Budget Committee is not a severable part of this section.
24 If the requirement of approval by the Legislative Council or Joint Budget
25 Committee is ruled unconstitutional by a court of competent jurisdiction,
26 this entire section is void.

27
28 SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
29 authorized by this act shall be limited to the appropriation for such agency
30 and funds made available by law for the support of such appropriations; and
31 the restrictions of the State Procurement Law, the General Accounting and
32 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
33 Procedures and Restrictions Act, or their successors, and other fiscal
34 control laws of this State, where applicable, and regulations promulgated by
35 the Department of Finance and Administration, as authorized by law, shall be
36 strictly complied with in disbursement of said funds.

2 SECTION 11. LEGISLATIVE INTENT. It is the intent of the General
3 Assembly that any funds disbursed under the authority of the appropriations
4 contained in this act shall be in compliance with the stated reasons for
5 which this act was adopted, as evidenced by the Agency Requests, Executive
6 Recommendations and Legislative Recommendations contained in the budget
7 manuals prepared by the Department of Finance and Administration, letters, or
8 summarized oral testimony in the official minutes of the Arkansas Legislative
9 Council or Joint Budget Committee which relate to its passage and adoption.
10

11 SECTION 12. EMERGENCY CLAUSE. It is found and determined by the
12 General Assembly, that the Constitution of the State of Arkansas prohibits
13 the appropriation of funds for more than a one (1) year period; that the
14 effectiveness of this Act on July 1, 2011 is essential to the operation of
15 the agency for which the appropriations in this Act are provided, and that in
16 the event of an extension of the legislative session, the delay in the
17 effective date of this Act beyond July 1, 2011 could work irreparable harm
18 upon the proper administration and provision of essential governmental
19 programs. Therefore, an emergency is hereby declared to exist and this Act
20 being necessary for the immediate preservation of the public peace, health
21 and safety shall be in full force and effect from and after July 1, 2011.
