17	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19	SECTION 1. Arkansas Code § 5-71-230 is amended to read as follows:
20	5-71-230. Violation of the protection of peace for mourning at a
21	funeral.
22	(a) As used in this section:
23	(1)(A) "Funeral" means a ceremony or memorial service held in
24	connection with the burial or cremation of a person who has died <u>in which th</u>
25	family of the deceased has a personal stake in memorializing and honoring th
26	deceased and the desire to be able to mourn in peace during the ceremony or
27	memorial service.
28	(B) "Funeral" does not include a procession related to th
29	funeral; and
30	(2) "Picket" means to engage in the activity of protesting or
31	demonstrating to target a funeral without authorization from the family of
32	the deceased.
33	(b) A person commits the offense of violation of the protection of
34	peace for mourning at a funeral if the person:
35	(1) Knowingly pickets a funeral;
36	(2) Intends to interfere with the funeral; and

1	(3) Pickets:
2	(A) Within one hundred fifty feet (150') three hundred
3	feet (300') of any ingress or egress of the funeral; and
4	(B) Either:
5	(i) During the funeral;
6	(ii) Within thirty (30) minutes immediately before
7	the scheduled commencement of the funeral; or
8	(iii) Within thirty (30) minutes immediately
9	following the completion of the funeral.
10	(c)(l) Violation of the protection of the peace for mourning at a
11	funeral is a Class C misdemeanor.
12	(2) A person commits a separate offense for each funeral that
13	the person pickets in violation of this section.
