20	SECTION 1. Arkansa	s Code § 2-16-206 is amende	d to add an addition

23	(a) There is creat	ed and established a State	Plant Board, composed of
24	sixteen (16) members, as	follows:	
25	(1) The head	of the Department of Entom	ology, University of

28	Arkansas College of Agric	ulture;

- 4 (8) A practical seed grower, actively engaged in the business,
- 5 to be elected by the Arkansas Seed Growers Association;
- 6 (9) A pest control operator, actively engaged in the business,
- 7 to be elected by the Arkansas Pest Control Association, Inc.;
- 8 (10) A seed dealer, actively engaged in the business, to be
- 9 elected by the Arkansas Seed Dealers Association;
- 10 (11) A feed manufacturer, actively engaged in the business, to
- 11 be elected by the Arkansas Feed Manufacturers Association;
- 12 (12) A pesticide manufacturer, actively engaged in the business,
- 13 to be elected by the Arkansas Agricultural Pesticide Association;
- 14 (13) One (1) member to represent the Arkansas Agricultural
- 15 Aviation Association, to be elected by the Arkansas Agricultural Aviation
- 16 Association:
- 17 (14) One (1) member to represent the Arkansas Forestry
- 18 Association, to be elected by the Arkansas Forestry Association; and
- 19 (15) Two (2) farmers actively and principally engaged in farming
- 20 in this state, appointed by the Governor.
- 21 (b) Board members shall serve a term of two (2) years or until such
- 22 time as a successor has been elected or appointed as herein provided. A
- 23 majority of the members of the board shall constitute a quorum for all
- 24 purposes.
- 25 (c) The chair of the State Plant Board, vice chair of the State Plant
- 26 Board, and secretary-treasurer of the State Plant Board shall be elected by
- 27 the members of the board. The board shall designate some official or employee
- 28 of the board to serve as disbursing officer of the board.
- 29 (d) Meetings of the board shall be called by the chair <u>of the State</u>
- 30 Plant Board or by four (4) members of the board.
- 31 (e) The members shall serve without compensation but may receive
- 32 expense reimbursements in accordance with \$25-16-901\$ et seq. and shall be
- 33 authorized to provide a suitable office where the meetings of the board may
- 34 be held and its records kept.
- 35 (f) If necessary to provide suitable space for its offices,
- 36 laboratories, and other needs, the board may buy property, build buildings,

1	or lease property for a period covering not more than fifteen (15) years from
2	the date of lease.
3	(g)(1) The board may form committees of its membership to make
4	recommendations to the board on areas of the board's jurisdiction.
5	(2) The chair of the State Plant Board shall appoint members to
6	a committee as necessary and appoint one (1) of those members as chair of the
7	<pre>committee.</pre>
8	(3)(A) Members of a committee shall serve at the pleasure of the
9	chair of the State Plant Board and he or she may change the membership of a
10	committee as necessary.
11	(B) The chair of a committee serves at the pleasure of the
12	chair of the State Plant Board.
