30 SECTION 42. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NON 32 HAZARDOUS SITE CLEAN UP RESTRICTIONS. Expenditures from the Arkansas 33 Department of Environmental Quality Fee Trust Fund for the cleanup of non 34 hazardous sites which pose a threat to the environment, as appropriated in 35 Section 33, shall be funded only through interest earnings from the Arkansas 36 Department of Environmental Quality Fee Trust Fund. The Arkansas Department

1 of Environmental Quality shall seek cost recovery from parties responsible 2 for damages to the environment that dictate the use of appropriation 3 authorized in Section 33 of this act, as well as, any other funds spent by a 4 governmental entity to remediate such non hazardous sites. 5 6 SECTION 43. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LANDFILL 8 DISPOSAL FEES. (a)(1) The collection of all landfill disposal fees that are 9 or were to be collected under § 8-6-612 shall be suspended until July 1, 2011 10 2012, and collection of the following landfill disposal fees shall be 11 substituted until that date: 12 (A) Each landfill permittee shall pay fifteen cents (15¢) 13 per uncompacted cubic yard of solid waste; and 14 (B) Each landfill permittee shall pay thirty cents (30¢) 15 per compacted cubic yard of solid waste received at the landfill. 16 (2) If a landfill permittee is required or chooses to operate on 17 a weight basis, the landfill disposal fee shall be one dollar (\$1.00) per ton 18 of solid waste received at the landfill. 19 The following shall be exempt from payment of fees under (b) 20 subsection (a) of this section: 21 (1) A solid waste transporter under § 8-6-603(10); and 22 (2) A landfill permittee where a private industry bears the 23 expense of operating and maintaining the landfill solely for the disposal of 24 wastes generated by the industry. 25 (c) The fees under subdivisions (a) of this section shall be: 26 (1) Collected in the same manner as stated in § 8-6-607(1) and 27 (2); and 28 (2) Deemed to be special revenues to be deposited into the State 29 Treasury to the credit of the Solid Waste Management and Recycling Fund for support of the computer and electronic recycling program. 30 31 Solid waste collected during the annual Keep Arkansas Beautiful (d) 32 and Keep America Beautiful campaigns that are sponsored by the Keep Arkansas 33 Beautiful Commission is exempt from the fees under subsection (a) of this 34 section. 35 36 SECTION 44. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

1 authorized by this act shall be limited to the appropriation for such agency 2 and funds made available by law for the support of such appropriations; and 3 the restrictions of the State Procurement Law, the General Accounting and 4 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 5 Procedures and Restrictions Act, or their successors, and other fiscal 6 control laws of this State, where applicable, and regulations promulgated by 7 the Department of Finance and Administration, as authorized by law, shall be 8 strictly complied with in disbursement of said funds.

10 SECTION 45. LEGISLATIVE INTENT. It is the intent of the General 11 Assembly that any funds disbursed under the authority of the appropriations 12 contained in this act shall be in compliance with the stated reasons for 13 which this act was adopted, as evidenced by the Agency Requests, Executive 14 Recommendations and Legislative Recommendations contained in the budget 15 manuals prepared by the Department of Finance and Administration, letters, or 16 summarized oral testimony in the official minutes of the Arkansas Legislative 17 Council or Joint Budget Committee which relate to its passage and adoption. 18

19 SECTION 46. EMERGENCY CLAUSE. It is found and determined by the 20 General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the 21 22 effectiveness of this Act on July 1, 2011 is essential to the operation of 23 the agency for which the appropriations in this Act are provided, and that in 24 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2011 could work irreparable harm 25 26 upon the proper administration and provision of essential governmental 27 programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health 28 29 and safety shall be in full force and effect from and after July 1, 2011. 30 31 32 33 34
