7	(ii) Appointed from the state at large subject to
8	confirmation by the Senate; and
9	(iii) A full voting member.
10	(3) The person who is elected as president of the Arkansas
11	Municipal Police Association or his or her designee shall be a full voting
12	member of the commission during his or her term of office as president of the
13	association, and his or her successors shall likewise serve as full voting
14	members of the commission.
15	(c) Except for the president of the Arkansas Municipal Police
16	Association, members Members shall be appointed for terms of seven (7) years
