21	SECTION 1. Arka	ansas Code § 18-16-407(a), concernin	g notice of sale in
22	default of self-storage	ge, is amended to read as follows:	
23	(a) Before cond	ducting a sale under § 18-16-406, th	e operator shall:
24	(1) Noti:	fy the occupant in writing of the de	fault. The notice
25	shall be sent by cert:	ified mail, return receipt requested	- certificate of
26	mailing to the occupa	nt at the occupant's last known addr	ess, and shall
27	include:		
28	(A)	A statement that the contents of t	he occupant's leased
29	space are subject to	the operator's lien;	
30	(B)	A statement of the operator's clai	m, indicating the
31	charges due on the da	te of the notice, the amount of any	additional charges
32	which that shall become due before the date of sale, and the date those		
33	additional charges sha	all become due;	
34	(C)	A demand for payment of the charge	s due within a
35	specified time, not le	ess than fourteen (14) days after th	e date that the
36	notice was mailed;		

1	(D) A statement that unless the claim is paid within the		
2	time stated, the contents of the occupant's space will be sold at a specified		
3	time and place;		
4	(E) The name, street address, and telephone number of the		
5	operator or his or her designated agent, whom the occupant may contact to		
6	respond to the notice; and		
7	(F) Designation of the date, time, and place where the		
8	contents will be sold unless the default is remedied prior to sale;		
9	(2) Publish one (1) advertisement in a newspaper of general		
10	circulation in the county in which the storage facility is located at least		
11	seven (7) days prior to sale; and		
12	(3)(A) Contact the circuit clerk in the county where the		
13	personal property is stored to determine the name and address of any holder		
14	of liens or security interests in the personal property being sold.		
15	(B)(i) The owner shall notify by certified mail, return		
16	receipt requested, certificate of mailing each holder of a lien or security		
17	interest of the time and place of the proposed sale at least ten (10) days		
18	prior to conducting the sale.		
19	(ii) The owner shall be required to notify the		
20	holder of a lien or security interest only if the lien or security interest		
21	is filed under the name of the occupant.

23	SECTION 2. Arkansas Code § 18-16-409(a), concerning the default		
24	mailing rule for notices regarding self storage, is amended to read as		
25	follows:		
26	(a) Unless otherwise specifically provided, all notices required by		
27	this subchapter shall be sent by certified mail, return receipt requested,		
28	certificate of mailing.
