13 AN ACT TO PLACE LIMITATIONS ON THE
14 COLLECTION OF LANDFILL FEES.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code § 8-6-612 is amended to read as follows:

20 8-6-612. Landfill disposal fees to support a computer and electronic
21 equipment recycling program.

22 (a)(1) Except as provided in subsection ~~(e) or (d)~~ (c) or (e) of this
23 section, there is imposed on each landfill permittee until July 1, 2012, a
24 landfill disposal fee of:

25 (A) ~~Twenty five cents (25¢)~~ Fifteen cents (15¢) for each
26 uncompact cubic yard of solid waste; and

27 (B) ~~Forty five cents (45¢)~~ Thirty cents (30¢) for each
28 compact cubic yard of solid waste received at the landfill.

29 (2) If a landfill permittee is required or chooses to operate on
30 a weight basis, the landfill disposal fee shall be one dollar (\$1.00) for
31 each one (1) ton of solid waste received at the landfill.

32 ~~(b)(1) Except as provided in subsections (a) and (c) of this section,~~
33 ~~for all solid waste generated and transported within the state but to be~~
34 ~~disposed of outside the state, there is imposed on each solid waste~~
35 ~~transporter a solid waste transportation fee of:~~

36 (A) ~~Twenty five cents (25¢) for each uncompact cubic~~



1 ~~yard of solid waste transported; and~~

2 ~~(B) Forty five cents (45¢) for each compacted cubic yard~~
3 ~~of solid waste transported.~~

4 ~~(2) If a solid waste transporter chooses to operate on a weight~~
5 ~~basis, the solid waste transportation fee shall be one dollar (\$1.00) for~~
6 ~~each one (1) ton of solid waste transported in the state.~~

7 (b) Except as provided in subsection (c) or (e) of this section, a fee
8 is imposed on each landfill permittee effective on July 1, 2012, as follows:

9 (1) Twenty-five cents (25¢) for each uncompact cubic yard of
10 solid waste transported; and

11 (2) Forty-five cents (45¢) for each compacted cubic yard of
12 solid waste transported.

13 (c) The following are exempt from payment of fees under subsections
14 (a) and (b) of this section:

15 (1) A solid waste transporter as defined in § 8-6-603; and

16 (2) A landfill permittee that is a private industry that bears
17 the expense of operating and maintaining the landfill solely for the disposal
18 of wastes generated by the industry.

19 ~~(e)(d)~~ Fees imposed under this section shall be collected in the same
20 manner as in § 8-6-607(1) and (2) and shall be special revenues deposited
21 into the State Treasury to the credit of the Solid Waste Management and
22 Recycling Fund for support of the computer and electronic equipment recycling
23 program.

24 ~~(d)(e)~~ Solid waste collected during the annual Keep Arkansas Beautiful
25 and Keep America Beautiful campaigns that are sponsored by the Keep Arkansas
26 Beautiful Commission is exempt from the landfill disposal fee under this
27 section.
