- SECTION 3. Arkansas Code Title 5, Chapter 73, Subchapter 3 is amended to add a new section to read as follows:
- 16 <u>5-73-322. Concealed handguns on a university, college, or community</u> 17 college campus.
- 18 (a) As used in this section:
- (1) "Campus" means the grounds and buildings owned or leased by
- 20 <u>a university</u>, college, or community college; and
- 21 (2) "Staff member" means a person who is employed full-time or
- 22 is on a nine-month appointment as a faculty member by a university, college,
- 23 or community college and who is not enrolled as a full-time student at the
- 24 university, college, or community college.
- 25 (b) A licensee may carry a concealed handgun on the public university,
- 26 public college, or public community college campus where he or she is
- 27 <u>employed if he or she is a staff member unless otherwise prohibited by § 5-</u>
- 28 73-306.
- 29 (c) A licensee may carry a concealed handgun on the private university
- 30 or private college campus where he or she is employed unless otherwise
- 31 <u>prohibited by § 5-73-306 if:</u>
- 32 (1) He or she is a staff member; and
- 33 (2) The private university or private college does not expressly
- 34 disallow the carrying of a concealed weapon on campus.
- 35 (d) The storage of a handgun in a student dormitory or residence hall
- is prohibited, as described in § 5-73-119(c).
