23	SECTION 2. Arkansas Code § 27-16-1105(a), concerning the minimum
24	issuance standards for driver's licenses, is amended to add an additional
25	subdivision to read as follows:
26	(3)(A)(i) The office may establish by rule a written and defined
27	exceptions process for a person who is unable to present all the necessary
28	documents for a driver's license or identification card and who must rely
29	upon alternate documents.
30	(ii) The office shall accept alternate documents only to
31	establish identity or date of birth of the person.
32	(B) A person wishing to obtain a driver's license or
33	identification card using alternate documents shall demonstrate to the office
34	that the person is relying on alternate documents due to reasons beyond the
35	person's control.
36	(C)(i) The office shall determine whether the alternate
