4	(a)(1) The Director of the Department of Finance and Administration		
5	shall accept requests from the Department of Parks and Tourism to create and		
6	issue special license plates under this subchapter.		
7	(2) The Department of Parks and Tourism shall submit with a		
8	request for a special license plate a proposed design for the approval of the		
9	director.		
10	(b) When considering a request from the Department of Parks and		
11	Tourism for a special license plate, the director shall consider the		
12	following factors:		
13	(1) The administrative cost to the Department of Finance and		
14	Administration for issuance of a Department of Parks and Tourism special		
15	license plate; and		
16	(2) The estimated demand for the special license plate requested		
17	by the Department of Parks and Tourism.		
18	(c)(l) If a request submitted under subsection (a) of this section is		
19	approved, the director shall determine:		
20	(A) The fee for the cost of initial orders of new designs		
21	for special license plates that shall be based on the cost of initial orders		
22	of new designs for special license plates;		
23	(B) The number of applications that must be received to		
24	cover the cost of the initial orders of new designs for special license		
25	plates; or		
26	(C) The combination of subdivisions (c)(1)(A) and (B) of

4	27-24-1603. Issuance — Renewal — Replacement.		
5	(a) A person who owns a motor vehicle and who is a resident of the		
6	state may apply for and renew annually a special license plate under this		
7	subchapter.		
8	(b) An applicant shall remit the following fees to obtain a special		
9	license plate issued under this subchapter for use on a motor vehicle:		
10	(1) The fee required by law for the registration and licensing		
11	of the motor vehicle;		
12	(2)(A) A fee not to exceed twenty-five dollars (\$25.00) to cover		
13	the design-use contribution by the Department of Parks and Tourism or to		
14	cover contributions for fundraising purposes.		
15	(B) The fee remitted under subdivision (b)(2)(A) of this		
16	section shall be deposited into a cash fund to be used by the Department of		
17	Parks and Tourism for the following purposes:		
18	(i) Sponsoring college scholarships related to the		
19	<u>field of conservation; and</u>		
20	(ii) Providing conservation education programs; and		
21	(3)(A) A handling and administrative fee in the amount of ten		
22	dollars (\$10.00).		
23	(B) The fee remitted under subdivision (b)(3)(A) of this		
24	section shall be:		
25	(i) Deposited into the State Central Services Fund		
26	for the benefit of the Revenue Division of the Department of Finance and		
27	Administration; and		
28	(ii) Credited as supplemental and in addition to all		
29	other funds as may be deposited for the benefit of the division.		
30	(C) The fee remitted under subdivision (b)(3)(A) of this		
31	section shall not be considered or credited to the division as direct		
32	revenue.		
33	(c) To renew a special license plate issued under this subchapter, the		
34	owner of the motor vehicle shall remit the fees stated in subsection (b) of		
35	this section.		
36	(d) To replace a special license plate issued under this subchapter		

1	the owner of the motor vehicle shall remit:
2	(1) The fee stated in subdivision (b)(3) of this section if the
3	registration has not expired; or
4	(2) The fees stated in subsection (b) of this section if the
5	registration has expired.
6	(e) The registration of a special license plate under this subchapter
7	may:
8	(1) Continue from year to year if it is renewed each year within
9	the time and manner required by law; and
10	(2) Be renewed as provided in § 27-14-1012.
