(B)(i) Upon review of the submitted data for any contract,
including an employment contract as provided in subsection (b) of this
section, the commissioner, within ten (10) twenty (20) days of receipt of the
resolution and other relevant data, shall approve or disapprove in writing
the board's request.

7 (ii) The commissioner may request additional 8 information or testimony before ruling on a request. If additional data are 9 needed for a proper determination, the commissioner shall approve or 10 disapprove the contract within ten (10) twenty (20) days of receipt of the 11 additional requested data.

(iii) If the commissioner does not respond to the public educational entity within the <u>ten-day twenty-day</u> period or request additional time or data for a proper review of the contract, the contract shall be deemed to be approved by the commissioner.

16 (C) If approved, the commissioner shall issue an approval 17 letter stating all relevant facts and circumstances considered and any 18 restrictions or limitations pertaining to the approval. The commissioner may 19 grant the approval for a particular transaction or contract, a series of 20 related transactions or contracts, or employment contracts. However, <del>no</del> 21 approval shall <u>not</u> be granted for a period greater than two (2) <u>complete and</u> 22 <u>consecutive fiscal</u> years, excluding employment contracts.

24 SECTION 2. Arkansas Code § 6-24-106(c)(3)-(5), concerning ethical 25 guidelines for administrators, is amended to read as follows:

26 (3)(A) An administrator seeking to contract with other public 27 educational entities, or an administrator's family member seeking to contract 28 with the public educational entity employing the administrator, shall first 29 present the request, with all relevant facts and circumstances justifying 30 approval, to the board currently employing the administrator at an open 31 meeting.

32 (B)(i) After reviewing the request in an open meeting, the 33 board may, by written resolution, approve the contract subject to approval by 34 the commissioner.

35 (ii) A copy of the approval resolution and all
 36 relevant data shall be forwarded by the board president to the commissioner.

1 (iii) The written resolution and other relevant data 2 shall be sent by certified mail, return receipt requested, or other method approved by the State Board of Education to assure that adequate notice has 3 4 been received by the Department of Education and to provide a record for the 5 school district board of directors sending the request for approval. 6 (4)(A) Upon review of the submitted data, the commissioner 7 shall, within ten (10) twenty (20) days of receipt of the resolution and 8 other relevant data, approve or disapprove in writing the board's request. 9 (B) The commissioner may request additional information or 10 testimony before ruling on a request. If additional data is needed for a 11 proper determination, the commissioner shall approve or disapprove the 12 contract within  $\frac{10}{10}$  twenty (20) days of receipt of the additional 13 requested data. 14 (C) If the commissioner does not respond to the public 15 educational entity within the ten-day twenty-day period or request additional 16 time or data for a proper review of the contract, the contract shall be 17 deemed to be approved by the commissioner. 18 (5) If approved, the approval letter shall state all relevant 19 facts and circumstances considered in the approval and shall state any 20 restrictions or limitations of the approval. The commissioner may grant an 21 approval for a particular transaction or a series of related transactions. No 22 approval shall be granted for a period greater than two (2) complete and 23 consecutive fiscal years. 24 25 SECTION 3. Arkansas Code § 6-24-107(b)(2)(A)-(C), concerning ethical 26 guidelines for employees, is amended to read as follows: 27 (A)(i) If it appears that the total transactions with an 28 employee for a fiscal year total, or will total, five thousand dollars 29 (\$5,000) or more, the superintendent or other chief administrator of the public educational entity shall forward the written resolution along with all 30 31 relevant data to the Commissioner of Education for independent review and 32 approval. 33 (ii) The written resolution and other relevant data shall be furnished sent by certified mail, with return receipt requested, or 34 35 other method approved by the State Board of Education to assure that adequate 36 notice of receipt has been received by the Department of Education and to

provide a record for the school district board of directors sending the approval request for approval. (B)(i) Upon review of the submitted data, the commissioner shall, within ten (10) twenty (20) days of receipt of the resolution and other relevant data, approve or disapprove in writing the board's request. (ii) The commissioner may request additional information or testimony before ruling on a request. If additional data is needed for a proper determination, the commissioner shall approve or disapprove the contract within ten (10) twenty (20) days of receipt of the additional requested data. (iii) If the commissioner does not respond to the public educational entity within the ten-day twenty-day period or request additional time or data for a proper review of the contract, the contract shall be deemed to be approved by the commissioner. (C) If approved, the commissioner shall issue an approval letter stating all relevant facts and circumstances considered and any restrictions or limitations pertaining to the approval. The commissioner may grant the approval for a particular transaction or a series of related transactions. However, no approval shall not be granted for a period greater than two (2) complete and consecutive fiscal years.
