30	SECTION 2. COM	IPLIANCE WITH OTHER LAWS. Disbursement	of funds
31	authorized by this a	ect shall be limited to the appropriation	n for such agency
32	and funds made avail	able by law for the support of such app	ropriations; and
33	the restrictions of	the State Procurement Law, the General	Accounting and
34	Budgetary Procedures	Law, the Revenue Stabilization Law, the	e Regular Salary
35	Procedures and Restr	rictions Act, or their successors, and o	ther fiscal

1	the Department of Finance and Administration, as authorized by law, shall be		
2	strictly complied with in disbursement of said funds.

4	SECTION 3. LEGISLATIVE INTENT. It is the intent of the General		
5	Assembly that any funds disbursed under the authority of the appropriations		
6	contained in this act shall be in compliance with the stated reasons for		
7	which this act was adopted, as evidenced by the Agency Requests, Executive		
8	Recommendations and Legislative Recommendations contained in the budget		
9	manuals prepared by the Department of Finance and Administration, letters,		
10	summarized oral testimony in the official minutes of the Arkansas Legislative		
11	Council or Joint Budget Committee which relate to its passage and adoption.		
12			
13	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General		
14	Assembly, that the Constitution of the State of Arkansas prohibits the		
15	appropriation of funds for more than a one (1) year period; that the		
16	effectiveness of this Act on July 1, 2011 is essential to the operation of		
17	the agency for which the appropriations in this Act are provided, and that is		
18	the event of an extension of the legislative session, the delay in the		
19	effective date of this Act beyond July 1, 2011 could work irreparable harm		
20	upon the proper administration and provision of essential governmental		
21	programs. Therefore, an emergency is hereby declared to exist and this Act		
22	being necessary for the immediate preservation of the public peace, health		
23	and safety shall be in full force and effect from and after July 1, 2011.
