1	(a) The following may apply to the Arkansas Arts Council to designate
2	an arts and cultural district:
3	(1) A city or county for an area within the city or county;
4	(2) With the prior consent of the city, a county, on its own
5	behalf or on behalf of a city, for an area in the city; or
6	(3) Two (2) or more cities or counties jointly for an area at
7	least partially located in each city or county.
8	(b) The application shall:
9	(1) Be in the form and manner and contain the information
10	required by the council;
11	(2) Contain sufficient information to allow the council to
12	determine if the proposed district qualifies under § 15-11-802(2); and
13	(3) Be submitted for a city or county by the chief elected
14	officer or, if none, the governing body of the city or county.

17	The Arkansas Arts Council shall promulgate rules to implement this
