Voter qualification. 14 (a) To be qualified to vote, a person shall have registered at least 15 thirty (30) calendar days immediately prior to the election and in the manner set forth by Arkansas Constitution, Amendment 51. 16 17 (b) "Voting residence" shall be a voter's domicile and shall be 18 governed by the following provisions: 19 (1) The domicile of a person is that place in which his or her 20 habitation is fixed to which he or she has the intention to return whenever 21 he or she is absent: 22 (2) A change of domicile is made only by the act of abandonment, 23 joined with the intent to remain in another place. A person can have only one 24 (1) domicile at any given time; 25 (3) A person does not lose his or her domicile if he or she 26 temporarily leaves his or her home and goes to another country, state, or 27 place in this state with the intent of returning; 28 (4) The place where a person's family resides is presumed to be 29 his or her place of domicile, but a person may acquire a separate residence 30 if he or she takes another abode with the intention of remaining there; 31 (5) A married person may be considered to have a domicile 32 separate from that of his or her spouse for the purposes of voting or holding office. (b)(1) A person who is a resident of a licensed nursing home, licensed 33 residential care facility, licensed assisted-living facility, or any licensed 34 facility that provides long-term medical or personal care is not required to 35 36 provide proof of identity before voting.
