practical, the State Treasurer shall transfer and credit to the "88th Session
 Projects Account" of the "General Improvement Fund", upon certification of
 the amounts thereof by the Chief Fiscal Officer of the State, the following:

(a) all unobligated and unallocated monies remaining in the "General
Improvement Fund" on June 30, 2011 which are not required to finance projects
to be financed there from pursuant to appropriations enacted by the 87th
General Assembly, or which have not been reappropriated or reallocated for
financing from the "General Improvement Fund" by the 88th General Assembly;

9 (b) any unobligated or unallocated funds remaining on July 2, 2011 in 10 the "General Revenue Allotment Reserve Fund" from monies accruing thereto 11 during the 2009-2011 fiscal biennium which are not required to finance 12 enactments of the 88th General Assembly that do not expire on June 30, 2011;

13 (c) interest earned on State Treasury fund balances as provided in
14 this subsection. For the period commencing on July 1, 2011, and ending June
15 30, 2013, the State Treasurer shall, after complying with provisions of

16 (1) Arkansas Code 27-70-204 for distributing interest income 17 earned from investment of average daily balances of the "State Highway and 18 Transportation Department Fund",

19(2) Arkansas Code 15-41-110 for distributing interest earned from20investment of average daily balances of the "Game Protection Fund", and

21 (3) Arkansas Code 20-78-504 for the next one hundred thousand 22 dollars (\$100,000) of interest income received each fiscal year by the State 23 Treasurer for the "Arkansas Child Care Facilities Loan Guarantee Trust Fund", credit to the "Budget Stabilization Trust Fund" or its successor fund, fifty 24 25 percent (50%) of the interest income received and credited to the "Securities 26 Reserve Fund", and credit to the "88th Session Projects Account" fifty 27 percent (50%) of the interest income received and credited to the "Securities 28 Reserve Fund" as certified by the Chief Fiscal Officer of the State, to 29 provide financing to the "88th Session Projects Account", until there has 30 been credited an amount, which when added to the other funds available for 31 such purposes will finance each of the projects or purposes hereinafter 32 enumerated;

4 SECTION 3. Of those moneys accruing to the 88th Session Projects Account of the General Improvement Fund as set out in Section 2 of this Act, 5 6 the State Treasurer shall first set-aside twenty six million four hundred 7 thousand three hundred and twelve dollars (\$26,400,312). In the event the 8 amount of funds actually transferred to the 88th Session Projects Account by 9 Section 2 (e) of this Act is less than ten million five hundred thousand 10 dollars (\$10,500,000) the State Treasurer shall adjust the amount first set aside to the amount less than ten million five hundred thousand dollars 11 12 (\$10,500,000) actually transferred. In no event shall the State Treasurer 13 decrease the amount first set aside by more than ten million five hundred 14 thousand dollars (\$10,500,000). 22	and this act being immediately necessary for the preservation of the public
23	peace, health and safety shall become effective on July 1, 2011.
