HOUSE BILL 1835

For An Act To Be Entitled

8 AN ACT TO PROVIDE THAT ARKANSAS STATE POLICE OFFICERS
9 SHALL NOT ENTER INTO EMPLOYMENT FOR SERVICES WITH A
10 GOVERNMENTAL BODY WITHIN THE JURISDICTION IN WHICH
11 THEY ARE ASSIGNED; AND FOR OTHER PURPOSES.

Subtitle

15 TO PROVIDE THAT ARKANSAS STATE POLICE
16 OFFICERS SHALL NOT ENTER INTO EMPLOYMENT
17 FOR SERVICES WITH A GOVERNMENTAL BODY
18 WITHIN THE JURISDICTION IN WHICH THEY ARE
19 ASSIGNED.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code Title 12, Chapter 12, Subchapter 2 is amended
25 to add a new section read as follows:

26 12-8-216. Prohibited activity.

27 (a) "Governmental body" means an office, department, commission,
28 council, board, committee, legislative body, agency, or other establishment
29 of the executive, judicial, or legislative branch of the state, municipality,
30 county, school district, improvement district, or any political district or
31 subdivision.

32 (b)(1) Effective January 1, 2012, a police officer with the Department
33 of Arkansas State Police shall not enter into a contract for services with a
34 governmental body in the division field office jurisdiction in which the
35 police officer is assigned.

36 (2) If, before January 1, 2012, a police officer has entered



1 into a contract for services with a governmental body in a division field
 2 office jurisdiction in which he or she is assigned and the contract extends
 3 past July 1, 2013, the police officer may fulfill the terms of the contract
 4 but shall not enter into a new contract with the governmental body.

5 (3) If a police officer has entered into a contract for services
 6 with a governmental body in a division field office jurisdiction in which he
 7 or she is not assigned and then is transferred into a division field office
 8 jurisdiction in which the governmental body is located and with which he or
 9 she has a contract for service, the police officer may fulfill the terms of
 10 the contract, but shall not enter into a new contract for services with the
 11 governmental body.
