3	(b) An advertisement by a gambling operator for a gambling activity		
4	published or broadcast in this state shall include a toll-free helpline		
5	telephone number providing information and referral services concerning		
6	compulsive gambling disorders.		
7	(c) In all printed, written, graphic, or Internet advertising, the		
8	toll-free helpline telephone number required under this section shall be		
9	displayed in a manner that is clear, identifiable, and conspicuous, but the		
10	number shall not be displayed in less than 8-point type print.		
11	(d) In all television advertising, the toll-free helpline telephone		
12	number required under this section shall:		
13	(1) Be clearly and conspicuously displayed; and		
14	(2) Remain on the screen for at least three (3) seconds.		
15	(e) In all radio advertising, the toll-free helpline telephone number		
16	required under this section shall be stated in a manner that is clear and		
17	understandable.		
18	(f) If a gambling operator operates an Internet website that provides		
19	information about or access to a gambling activity, the toll-free telephone		
20	number required under this section shall be displayed on the Internet websit		
21	in a manner that is clear, identifiable, and conspicuous, but the number		
22	shall not be displayed in less than 8-point type print.

24	SECTION 2. Arkansas Code § 23-115-410 is amended to read as follows:		
25	23-115-410. Compulsive gambling disorder treatment and educational		
26	programs.		
27	(a) The Arkansas Lottery Commission shall provide an annual amount of		
28	at least two hundred thousand dollars (\$200,000) for:		
29	(1) Compulsive gambling disorder treatment programs; and		
30	(2) Compulsive gambling disorder educational programs.		
31	(b)(1) The commission shall work together with the Department of Human		
32	Services to implement the compulsive gambling disorder treatment programs and		
33	the compulsive gambling disorder educational programs under this section.		
34	(2) The commission may contract with the department for		
35	providing all services related to and administration of the compulsive		
36	gambling disorder treatment programs and the compulsive gambling disorder

1	educational programs.
2	(3) As part of its compulsive gambling disorder treatment and
3	educational programs, the department shall make available a toll-free
4	helpline telephone number providing information and referral services
5	concerning compulsive gambling disorders.

7	compulsive gambling disorder treatment programs and the compulsive gambling
8	disorder educational programs.
