6	SECTION 2. Arkansas Code § 23-115-410 is amended to read as follows:
7	23-115-410. Compulsive gambling disorder treatment and educational
8	programs.
9	(a) The Arkansas Lottery Commission shall provide an annual amount of
10	at least two hundred thousand dollars (\$200,000) for:
11	(1) Compulsive gambling disorder treatment programs; and
12	(2) Compulsive gambling disorder educational programs.
13	(b)(1) The commission shall work together with the Department of Human
14	Services to implement the compulsive gambling disorder treatment programs and
15	the compulsive gambling disorder educational programs under this section.
16	(2) The commission may contract with the department for
17	providing all services related to and administration of the compulsive
18	gambling disorder treatment programs and the compulsive gambling disorder
19	educational programs.
20	(3) As part of its compulsive gambling disorder treatment and
21	educational programs, the department shall make available a toll-free
22	helpline telephone number providing information and referral services
23	concerning compulsive gambling disorders.
24	(3)(4) The department may promulgate rules to administer the
25	compulsive gambling disorder treatment programs and the compulsive gambling
26	disorder educational programs.
