- 5 being required to obtain a license, but the person or entity shall comply
- 6 with all other provisions of this subchapter.
- 7 (b) However, the twenty-thousand-dollar exception shall not apply to
- 8 any project of construction in which any of the construction work necessary
- 9 to complete the project, except any in-progress change orders, is divided
- 10 into separate contracts of amounts less than twenty thousand dollars
- 11 (\$20,000), a purpose being to circumvent the provisions of this chapter.
- 12 (c)(1)(A) It Except as provided in this subsection, it is the
- 13 intention of this definition to include all improvements, demolition, or

- 30 contractor in the construction, erection, alteration, or repair of his or her
- 31 own or its own property from a third party shall not be considered as a part
- 32 of the subcontractor's project, provided that the subcontract is for wood
- 33 framing, shingle roofing, painting, floor covering, or concrete labor.

- 35 SECTION 2. Arkansas Code § 17-25-502(2), concerning the definition of
- 36 "residential building contractor", is amended to read as follows:

1	(2) "Residential building contractor" means any person, firm,		
2	partnership, copartnership, association, corporation, or other organization		
3	or any combination thereof, which for a fixed price, commission, fee, or wage		
4	attempts to or submits a bid to construct or contract or undertakes to		
5	construct or assumes charge in a supervisory capacity or otherwise manages		
6	the construction of <u>no more than four (4)</u> single family residences <u>in a</u>		
7	single year; and

9	SECTION 3. Arkansas Code Title 17, Chapter 25, Subchapter 5 is amended		
10	to add an additional section to read as follows:		
11	17-25-515. Licensure of certain residential building contractors with		
12	Contractors Licensing Board.		
13	A residential building contractor that constructs five (5) or more		
14	single family residences in a single year shall be licensed with the		
15	Contractors Licensing Board.
