14	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the		
15	General Assembly of the State of Arkansas that the continued identification		
16	of school districts for consolidation solely on the basis of average daily		
17	membership interferes with the efficient and effective administration of		
18	public schools in small, rural school districts in this state; that the		
19	implementation of this act is essential to the operation of school districts		
20	affected by the act; and that this act is immediately necessary to allow the		
21	State Board of Education and the Department of Education sufficient time to		
22	develop rules and procedures to implement this act for school districts		
23	currently on the January 1, 2011 consolidation list. Therefore, an emergency		
24	is declared to exist and this act being immediately necessary for the		
25	preservation of the public peace, health, and safety shall become effective		
26	<u>on:</u>		
27	(1) The date of its approval by the Governor;		
28	(2) If the bill is neither approved nor vetoed by the Governor,		
29	the expiration of the period of time during which the Governor may veto the		
30	bill; or		
31	(3) If the bill is vetoed by the Governor and the veto is		
32	overridden, the date the last house overrides the veto.
