32	customer's personal check for an agreed period of time prior to presentment

7	No person shall engage in the check-cashing business without first
<i>.</i> 8	obtaining a permit from the State Board of Collection Agencies in accordance
9	with this chapter. A separate permit shall be required for each location from
10	which such check cashing business is conducted.

12	23-52-104. Permissible check-casher fees.
13	(a) A check-casher may charge a reasonable fee to defray operational
14	costs incurred in the check-cashing business, including, without limitation:
15	(1) Investigating the checking account and copying required
16	documents;
17	(2) Photographing the person signing the check;
18	(3) Securing check and customer records in a safe, fireproof
19	place;
20	(4) Maintaining records as required by this chapter;
21	(5) Maintaining required capital and liquidity; and
22	(6) Processing, documenting, and closing the check-cashing or
23	deferred-deposit transactions.
24	(b) Unless otherwise authorized by this chapter, the fees authorized
25	by this section shall not exceed the following:
26	(1) For the service of selling currency or check in exchange for
27	checks, without regard to whether a deferred presentment option is involved:
28	(A) A fee not to exceed five percent (5%) of the face
29	amount of the check if the check is the payment of any kind of state public
30	assistance or federal social security benefit payable to the bearer of the
31	check or the check is otherwise a check issued by a federal or state
32	governmental entity;
33	(B) A fee not in excess of ten percent (10%) of the face
34	amount of any personal check or money order; or
35	(C) A fee not in excess of six percent (6%) of the face
36	amount of the check in the case of all other checks. Such a fee may be

1 collected separately or by paying the customer an amount of money equal to 2 the face amount of the check less the appropriate fee under this chapter; 3 (2) For a deferred presentment option which involves a personal 4 check, an additional fee not to exceed ten dollars (\$10.00) may be charged by 5 a check-casher; and 6 (3) In addition to the foregoing fees, a check-casher may charge 7 a fee of no more than five dollars (\$5.00) to set up an initial customer 8 account and issue an optional identification card for providing check-cashing 9 services. A replacement optional identification card may be issued at a cost not to exceed five dollars (\$5.00). 10 11 12 23-52-105. General disclosure. 13 (a) Every check-casher, as applicable to the services provided, shall 14 post a complete, detailed, and unambiguous schedule of all fees for: 15 (1) Cashing checks and making any deferred presentment option 16 thereof; 17 (2) The sale or issuance of money orders; and 18 (3) The initial issuance of any identification card. 19 (b) Each check-casher shall also post a list of valid identification 20 which is acceptable in lieu of identification provided by the person cashing 21 the check. The information required by this section shall be posted at each 22 location at which the check-casher conducts the check-cashing business and in elear, legible letters not less than one-half inch (½") in height. The 23 information shall be posted in a conspicuous location in the unobstructed 24 25 view of the public within the check-casher's premises. 26 27 23-52-106. Other terms of doing the check-cashing business. (a) A check casher may not purchase a check for the purpose of 28 29 deferred presentment option without receiving from the customer a written certification that the account upon which the check is drawn is legitimate 30 31 and open. The certification may be contained in the body of the deferred presentment option agreement required by this chapter. 32 33 (b) Before a check-casher shall present for payment or deposit a check purchased by the check casher, the check shall be endorsed with the actual 34 name under which the check-casher is doing business. 35

(c) Any agreement for a deferred presentment option of a check shall

 be in writing and signed by the maker of the check. Such written agreement shall contain a written explanation in clear, understandable language of the fees to be charged by the check casher and the date on which the check will be deposited or presented by the check-casher. Without limitation, such explanation shall contain a statement of the total amount of any fees charged for the deferred presentment option expressed both in United States currency and as an annual percentage rate. Enactment of this subsection shall not create any inference that a particular method of disclosure was required prior to April 7, 1999.

(d) The maker of any check purchased by a check-casher and accepted

(d) The maker of any check purchased by a check-casher and accepted for deferred presentment option shall have the right to repurchase that check from the check-casher before the agreed date of deposit upon payment to the check-casher of the face amount of that check. If a check-casher accepts a partial payment, that check may not be presented for deposit nor may the check-casher charge any additional fee. A check-casher shall not defer presentment of any check for less than six (6) calendar days nor more than thirty-one (31) calendar days after the date the check is sold to the check-casher.

(c) A check-casher shall issue a copy of the written agreement to each person for whom a check-casher grants a repurchase option and defers deposit of a check.

(f) A check-easher shall comply with all provisions of state and federal law regarding eash transactions and eash transaction reporting.

(g) If a check is returned to the check-casher from a payer bank or other financial institution due to insufficient funds, closed account, or a stop payment order, the check-casher shall have the right to all civil remedies allowed by law to collect the check and shall be entitled to recover any returned check fee authorized by applicable Arkansas law, court costs, and reasonable attorney's fee paid to an attorney who is not a salaried employee of the check-casher.

(h) If a check is returned to a check-casher from a payer financial institution because there are insufficient funds in or on deposit with the financial institution to pay the check, the check-casher or any other person on behalf of the check-casher shall not institute or initiate any criminal prosecution against the customer who sold such check to the check-casher, unless the check-casher would otherwise be entitled to institute or initiate

1	a criminal prosecution against such customer under applicable Arkansas	
2	criminal law and such check is returned to the check-casher because:	
3	(1) The account on which such check was drawn was closed by the	
4	maker of the check, either before or during the term of the deferred	
5	presentment option agreement; and	
6	(2) Payment on the check was stopped by the maker of the check.	
7	(i) No check-casher may alter or delete the date on any check accepted	
8	by the check-casher.	
9	(j) No check-casher may accept an undated check or a check dated on a	
10	date other than the date on which the check-casher purchases the check.	
11	(k) Consistent with the nature of a deferred presentment option, no	
12	check-casher shall require a customer to provide security for the deferred	
13	presentment transaction or require the customer to provide a guaranty from	
14	another person.	
15	(1) Each check-casher shall pay all proceeds in eash for any check	
16	purchased.	
17	(m) No check-casher shall have more than one (1) deferred presentment	
18	check outstanding at any time from any one (1) customer per permitted	
19	location. A deferred presentment check purchased from any one (1) customer	
20	and outstanding at any one (1) time shall not exceed four hundred dollars	
21	(\$400).	
22	(n) A check-casher shall not renew or otherwise consolidate a deferred	
23	presentment option transaction with the proceeds of another deferred	
24	presentment option transaction made by the same customer.	
25		
26	23-52-107. Qualification for check-casher permit.	
27	A check-casher permit applicant shall satisfy the following	
28	requirements to qualify for a permit under this chapter:	
29	(1) The applicant shall have a minimum of eash or other liquid	
30	assets of at least twenty thousand dollars (\$20,000) for the operation of	
31	each location at which the applicant will engage in the check-cashing	
32	business and shall be required to post with the State Board of Collection	
33	Agencies a fifty-thousand-dollar bond payable to the State of Arkansas;	
34	(2) The financial responsibility, financial condition, and	
35	business experience of the applicant shall reasonably warrant the belief that	
36	the applicant's check-cashing business will be conducted in accordance with	

1	this chapter. In determining whether this qualification has been met and for
2	the purpose of investigating compliance with this chapter, the board may
3	review and approve the following:
4	(A) The relevant business records and the capital adequacy
5	of the applicant; and
6	(B) The competence, experience, and financial ability of
7	any person who is a member, partner, director, officer, or five percent (5%)
8	or more shareholder of the applicant or who otherwise controls the applicant;
9	(3) The requirements set forth in subdivisions (1) and (2) of
10	this section shall be continuing in nature; and
11	(4) The board shall deny an application for a permit to conduct
12	a check-cashing business or for renewal of a permit if the applicant or any
13	person referred to in subdivision (2)(B) of this section has a felony
14	conviction involving dishonesty, fraud, or deceit, provided the crime is
15	substantially related to the qualifications, functions, or duties of a person
16	engaged in the check-cashing business.
17	
18	23-52-108. Form of application for permit.
19	(a) Each application for a check-cashing permit shall be in writing in
20	a form prescribed by the State Board of Collection Agencies and shall include
21	at least the following:
22	(1) The legal name, residence, business address, and telephone
23	number of the applicant;
24	(2) If the applicant is a partnership, association, limited
25	liability company, or corporation, the name and address of every member,
26	officer, and director; and
27	(3) Such other data and information as the board may require
28	with respect to the applicant and its directors, officers, partners or
29	members.
30	(b) For each location at which the applicant wants to engage in the
31	check-cashing business, each application for a permit shall be accompanied by
32	both of the following:
33	(1) An initial permit fee of five hundred dollars (\$500) which
34	shall not be subject to refund; and
35	(2) A financial statement showing that the applicant has at
36	least twenty thousand dollars (\$20,000) in liquid or other eash assets

available for the operation of the check-cashing business prepared in accordance with standard accounting practices and procedures.

 23-52-109. Board action and issuance of permits.

- (a) Upon the filing of an application in the form prescribed by the State Board of Collection Agencies accompanied by the fees and documents required in this chapter, the board shall investigate to ascertain whether the qualifications prescribed by § 23-52-107 have been satisfied. If the board finds that the qualifications have been satisfied and approves the documents, the board shall issue to the applicant a permit to engage in the check-cashing business in Arkansas at the locations specified in the application as approved by the board.
- (b) No person engaged in the check-cashing business shall conduct any other business within the same location without having obtained prior written approval from the board.
- (c) The check-casher permit shall be kept conspicuously posted in the check-casher's place of business and shall not be assignable or transferable nor moved to another location without permission of the board.
- (d) In addition to the initial permit fee required by § 23-52108(b)(1), there shall be an annual permit fee of four hundred dollars (\$400)
 for each office, branch, or place of business of the check-casher, which
 shall be due on August 1 of each year. The annual permit fee shall be for a
 one-year period ending July 31 and shall be delinquent on September 1 of each
 year. There shall be a penalty of ten percent (10%) for each month or part
 thereof that the check-casher is delinquent in the payment of the annual
 permit fee. All permit fees collected by the board shall be used by the board
 in the supervision and examination of check-cashers and the issuance of
 permits under this chapter.
- (e) A person operating a check-cashing business on April 7, 1999, shall have until the beginning of the next permit year after April 7, 1999, to apply for a permit under this chapter and to pay the required permit fee, and upon qualification and payment of the required fee shall be granted a permit under this chapter. Provided, that the check-casher shall comply with the other provisions of this chapter pending the application.
- (f) A check-casher may voluntarily surrender its permit to the board.

 However, the check-casher shall not be entitled to receive a refund of any

permit fees previously paid. Upon surrender, the check-casher shall immediately make available to the board all books, records, and papers required to be created and maintained under this chapter or regulations promulgated by the board under this chapter.

23-52-110. Change of control of check-casher.

The prior written approval of the State Board of Collection Agencies shall be required for the continued operation of a check-cashing business whenever a change in control of a permitted check-casher is proposed. Control in the case of a corporation shall mean direct or indirect ownership, the right to control twenty-five percent (25%) or more of the voting shares of the corporation, or the ability of a person to elect a majority of the directors. Control in the case of any other entity shall mean the ability to change the principles of the organization, whether active or passive. The board may require information deemed necessary to determine whether a new application is required.

23-52-111. Regulations.

The State Board of Collection Agencies is authorized and empowered to promulgate reasonable regulations for the execution and enforcement of this chapter. However, before any rules and regulations promulgated by the board shall be effective, they must be issued in accordance with the Arkansas Administrative Procedure Act, § 25-15-201 et seq.

23-52-112. Records and inspections.

(a) Each check-casher shall keep and use in its business any books, accounts, and records that the State Board of Collection Agencies may require to carry into effect the provisions of this chapter and the administrative regulations issued hereunder. Provided, such records may be retained on computer or other electronic storage devices.

(b) For the purpose of determining compliance with this chapter, the board, at any reasonable time, may cause an examination to be made at a check-casher's place of business of the records and transactions of such check-casher. Each check-casher shall preserve all relevant records for a period of at least two (2) years after making the last entry on any transaction, and the board shall have free access to such records at the

1 check-casher's place of business at all reasonable times during the check-2 casher's normal business hours. If the board has probable cause to believe 3 that a person has engaged in an activity which violates the provisions of 4 this chapter, the board may compel the production of such books and records 5 of the person as the board has probable cause to believe are relevant to the 6 alleged violation. 7 8 23-52-113. Appeal of permit denial. 9 (a) If the State Board of Collection Agencies determines that an 10 applicant is not qualified to receive a permit, the board shall notify the 11 applicant in writing that the application has been denied, stating the basis 12 for denial. 13 (b) If the board denies an application or if the board fails to act on 14 an application within ninety (90) days after the filing of a properly completed application, the applicant may make a written demand to the board 15 for a hearing before the board on the question of whether the permit should 16 17 be granted. 18 (c) At the hearing, the burden of proving that the applicant is 19 entitled to a permit under this chapter shall be on the applicant. A 20 decision of the board following any hearing on the denial of a permit may be 21 subject to review in accordance with the Arkansas Administrative Procedure 22 Act, § 25-15-201 et seq. 23 23-52-114. Revocation or suspension of permit. 24 25 (a) After notice and hearing, the State Board of Collection Agencies may suspend or revoke any permit if the Chairman of the State Board of 26 27 Collection Agencies finds that the check-casher either knowingly or through 28 lack of due care has committed one (1) of the following: 29 (1) Failed to pay the annual permit fee imposed by this chapter or an examination fee imposed by the board under the authority of this 30 31 *chapter;* 32 (2) Violated a provision of this chapter or an administrative 33 regulation issued pursuant to this chapter; and (3) Made a false statement in the application for the permit or 34 failed to give a true reply to a question in the application. 35 36 (b) If the reason for revocation or suspension of a permit of the

1 check-casher at any one (1) location is of general application to all 2 locations operated by a check-casher, the board may revoke or suspend all 3 permits issued to the check-casher. 4 (c) Any hearing under this section shall be held on written notice 5 given at least twenty (20) days prior to the date of the hearing. 6 7 23-52-115. Board remedies for violation of this chapter. 8 If after a hearing the State Board of Collection Agencies finds that a 9 person has violated this chapter or any administrative regulation issued pursuant to this chapter, the board may do any or all of the following; 10 11 (1) Order the person to cease and desist violating this chapter or any administrative rules issued pursuant thereto; 12 (2) Require the refund of any fees collected by the person in 13 14 violation of this chapter; and 15 (3) Order the person to pay to the board a civil penalty of not 16 more than one thousand dollars (\$1,000) for each transaction in violation of 17 this chapter or for each day that a violation has occurred and continues. 18 19 23-52-116. Consent orders. 20 (a) The State Board of Collection Agencies may enter into consent 21 orders at any time with any person to resolve any matter arising under this 22 chapter. A consent order shall be signed by the person to whom it is issued 23 or an authorized representative and shall indicate agreement to the terms contained therein. A consent order need not constitute an admission by any 24 25 person that any provision of this chapter or any rule, regulation, or order 26 promulgated or issued pursuant to this chapter has been violated, nor need it 27 constitute a finding by the board that the person has violated any provision of this chapter or any rule, regulation, or order promulgated or issued 28 29 hereunder. (b) Notwithstanding the issuance of a consent order, the board may 30 31 seek civil or criminal penalties or compromise civil penalties concerning 32 matters encompassed by the consent order. 33 34 23-52-117. Complaints.

(a) Without limiting any other right, power, or remedy of the State

1	pursuant to authority granted under § 4-88-101 et seq. pertaining to
2	deceptive trade practices, any person aggrieved by the conduct of a check-
3	casher under this chapter in connection with the regulated activities of the
4	check-casher may file a written complaint with the board, which may
5	investigate the complaint.
6	(b) In the course of the investigation of the complaint, the board may
7	do any or all of the following:
8	(1) Subpoena witnesses;
9	(2) Administer oaths;
10	(3) Examine any individual under oath; and
11	(4) Compel the production of records, books, papers, contracts,
12	or other documents relevant to the investigation.
13	(c) If a person fails to comply with a subpoena of the board under
14	this chapter or to testify concerning any matter about which the person may
15	be interrogated under this chapter, the board may petition any court of
16	competent jurisdiction for enforcement.
17	(d) The permit of any check-casher under this chapter who fails to
18	comply with a subpoena of the Chairman of the State Board of Collection
19	Agencies may be suspended pending compliance with the subpoena.
20	(c) A person who willfully makes charges in excess of those permitted
21	by § 23-52-104 or a person who willfully engages in the check-cashing
22	business in violation of this chapter is guilty of a Class A misdemeanor.
23	(f) Any action for a civil remedy under this chapter by the board or
24	any other person against a check-casher must be commenced within five (5)
25	years after the action or inaction giving rise to the right to seek such a
26	civil remedy.
