- 2 (d)(1) The petition shall be directed to the county clerk and shall
 3 contain the names of at least twenty (20) registered voters who are residents
 4 of the school district and, if applicable, the electoral zone for the

 - (2) The petition shall:
- 7 (A) State the name and title of the candidate that the 8 candidate proposes to appear on the ballot; and
- 9 (B) Identify the position sought, including without 10 limitation the position number or other identifying information if 11 applicable.
 - (e) The petition, affidavit of eligibility, and the candidate's political practices pledge shall be filed with the clerk during a one-week period ending at 12:00 noon sixty (60) seventy (70) days before the annual school election.

Certification of candidate lists. 12 (a)(1) Not less than seventy (70) seventy-five (75) days before each 13 general election day, the Secretary of State shall certify to all county 14 boards of election commissioners full lists of all candidates to be voted for 15 in their respective counties as the nominations have been certified or 16 otherwise properly submitted to him or her. 17 (2) A name of a person shall not be certified and shall not be 18 placed on the ballot if prior to the certification deadline a candidate on the list: 19 20 (A) Notifies the Secretary of State in writing, signed by 21 the candidate and acknowledged before an officer authorized to take 22 acknowledgements, of his or her desire to withdraw as a candidate for the 23 office or position; or 24 (B) Dies. 25 (b)(1) Not less than seventy (70) seventy-five (75) days before each 26 general election day, the clerk of each county shall certify to the county 27 board of his or her county a full list of all candidates to be voted for in the county as the nominations have been certified or otherwise properly 28 29 submitted to him or her. (2) A name of a person shall not be certified and shall not be 30 31 placed on the ballot if prior to the certification deadline a candidate on 32 the list: 33 (A) Notifies the county clerk in writing, signed by the 34 candidate and acknowledged before an officer authorized to take 35 acknowledgements, of his or her desire to withdraw as a candidate for the 36 office or position; or

1 (B) Dies.
2 (c) However, in special elections held to fill vacancies or to elect
3 officers in case of a tie vote, the certification shall issue at the time
4 specified in the writ of election issued by the appropriately constituted

authority.

SECTION 4. Arkansas Code § 7-5-204 is amended to read as follows: 7-5-204. Certification of measures and questions submitted to voters.

- (a) Whenever a proposed amendment to the Arkansas Constitution or other measure or question is to be submitted to a vote of the people, the Secretary of State shall not certify the amendment, measure, or question to the county board of election commissioners of each county in the state less than seventy (70) seventy-five (75) days before each general election day.
- (b) The county board shall include the amendment, measure, or question in the posting that it is required to make under § 7-5-206.
 - (c)(1) If the Secretary of State has not determined the sufficiency of a petition for an amendment or a measure by the seventieth seventy-fifth day before the general election or if an amendment or a measure has been challenged for any reason in a court of competent jurisdiction, the Secretary of State shall nonetheless transmit the amendment or measure and the ballot title of each amendment and measure to the county election commissions to make any required posting and to place the amendment or measure on the ballot.
 - (2) If the petition for the amendment or measure is subsequently declared insufficient by the Secretary of State or a court of competent jurisdiction or if held to be invalid for any other reason, no votes regarding the amendment or measure shall be counted or certified.

- SECTION 5. Arkansas Code § 7-5-205(3), concerning votes for write-in candidates, is amended to read as follows:
- 31 (3) The notice of write-in candidacy, the political 32 practices pledge, and the affidavit of eligibility are filed no earlier than 33 noon on the last day of the party filing period and not later than ninety 34 (90) days before the election day <u>no later than the last day of the party</u> 35 filing period; and

- 1 SECTION 6. Arkansas Code § 7-5-207 is amended to read as follows:
- 2 7-5-207. Ballots Names included Draw for ballot position.
- 3 (a)(1) Except as provided in subdivisions (a)(2) and (3) of this
- 4 section, all election ballots provided by the county board of election
- 5 commissioners of any county in this state for any election shall contain in
- 6 the proper place the name of every candidate whose nomination for any office
- 7 to be filled at that election has been certified to the county board and
- 8 shall not contain the name of any candidate or person who has not been

- 18 (A) Nonpartisan judicial election; or
- 19 (B) Nonpartisan municipal election.

- 21 SECTION 7. Arkansas Code § 7-5-407(a), concerning the preparation and
- 22 delivery of ballots, is amended to read as follows:
- 23 (a)(1) The county board of election commissioners shall prepare
- 24 official absentee ballots and deliver them to the county clerk for mailing to
- 25 all qualified applicants as soon as practicable but in any event not later
- 26 than thirty-five (35) forty-seven (47) days before a preferential primary,
- 27 general election, school election, nonpartisan judicial general election,

SECTION 8. Arkansas Code § 7-7-104(g)(1), concerning the selection of party nominees, is amended to read as follows:

(g)(1) If the party's nominee is not selected in time to file his or her certificate of nomination with the appropriate party authority at least sixty-six (66) seventy-six (76) days before the general election, the nominee's name shall not appear on the general election ballot but the name of the person who vacated the nomination shall appear on the ballot, and votes cast for the name of the person appearing on the ballot shall be counted for the nominee but only if the certificate of nomination is duly filed at least thirty-five (35) forty-seven (47) days before the general election.

- SECTION 9. Arkansas Code \S 7-7-203 is amended to read as follows: 7-7-203. Dates.
- 16 (a) The general primary election shall be held on the second Tuesday 17 in June preceding the general election.
 - (b) The preferential primary election shall be held on the Tuesday three (3) weeks before the general primary election.
- 20 (c) (1) The party filing period shall be a one-week period ending at
 21 12:00 noon on the first day in March and beginning at 12:00 noon one week
 22 prior to the first day in March.
 - (1)(2) Party pledges, if any, and affidavits of eligibility shall be filed, and any filing fees of a political party, if any, shall be paid, and party certificates shall be issued by the party during regular office hours during the party filing period in the period beginning at 12:00 noon on the first weekday in March and ending at 12:00 noon on the seventh day thereafter before the preferential primary election.
 - (2)(3) A party certificate and the political practice practices pledge for primary elections shall be filed with the county clerk or the Secretary of State, as the case may be, during regular office hours during the party filing period in the period beginning at 12:00 noon on the first weekday in March and ending at 12:00 noon on the seventh day thereafter before the preferential primary election.
- 35 (3)(4) The name of a candidate who fails to file a party
 36 certificate and political practices pledge by the filing deadline with the

- 4 (4)(5) Party pledges, if any, shall be filed, filing fees, if any, shall be paid, and party certificates and political practice pledges shall be filed for special primary elections on or before the deadline established by proclamation of the Governor or other entity authorized to call a special primary election.
 - (d)(1) At least seventy (70) seventy-five (75) days before the preferential primary election, the Secretary of State shall certify to the various county committees and to the various county boards of election commissioners a list of the names of all candidates who have filed party certificates with the Secretary of State within the time required by law.
 - (2) At least seventy (70) seventy-five (75) days before the preferential primary election, the county clerk shall certify to the county committees and to the county board of election commissioners a list of the names of all candidates who have filed party certificates with the county clerk within the time required by law.
 - (e)(1) The county board of election commissioners shall convene, at the time specified in the notice to the members given by the chair of the board, no later than the tenth day after each primary election for the purpose of canvassing the returns and certifying the election results.
 - (2) If no time is specified for the meeting of the county board of election commissioners, the meeting shall be at 5:00 p.m.
 - (f) The county convention of a political party holding a primary election shall be held on the first Monday following the date of the general primary election.
 - (g)(1) The county board of election commissioners shall certify to the county clerk and the county committee a list of all nominated candidates for county, township, and municipal offices, and the political parties' county committee members and delegates.
- 31 (2) At the same time, the county board of election commissioners 32 shall certify to the Secretary of State and the secretary of the state 33 committee the results of the contests for all United States, state, and 34 district offices. Immediately after ascertaining the results for all United 35 States, state, and district offices, the Secretary of State shall certify to 36 the state committee a list of all nominated candidates for the offices.

- (h)(1)(A) The Secretary of State shall at least one hundred (100) days before the date of the general election notify by registered mail the chair and secretary of the state committee of the respective political parties that a certificate of nomination is due for all nominated candidates for United States, state, and district offices in order that the candidates' names be placed on the ballot of the general election.
- 7 (B)(i) The state committee shall issue certificates of 8 nomination to all nominated candidates for United States, state, and district 9 offices, who shall file the certificates with the Secretary of State at least 10 ninety (90) days before the general election.
 - (ii) However, if the chair and secretary of the state committee of the respective political parties are not properly notified as directed by subdivision (h)(l)(A) of this section, the failure of a candidate to file a certificate of nomination by the deadline shall not prevent that candidate's name from being placed on the ballot of the general election.
 - (2)(A) Each county clerk shall at least ninety (90) one hundred (100) days before the date of the general election notify by registered mail the chairs and secretaries of the county committees of the respective political parties that a certified list of all nominated candidates for county, township, and municipal offices is due and shall be filed with the county clerk in order that the candidates' names be placed on the ballot for the general election.
 - (B)(i) Each county committee shall issue the certified list on behalf of those nominated candidates and submit the certified list to the county clerk at least eighty (80) ninety (90) days before the general election.
 - (ii) However, if the chairs and secretaries of the county committees of the respective political parties are not properly notified as directed by subdivision (h)(2)(A) of this section, the failure of a certified list to be filed by the deadline shall not prevent any candidate's name from being placed on the ballot of the general election.

SECTION 10. Arkansas Code § 7-7-304 is amended to read as follows:

7-7-304. Names to be included on ballots — Withdrawal — Unopposed

candidates — Position Designation of position — Necessity of general primary.

- (a)(1) Not less than seventy (70) seventy-five (75) days before each preferential primary election, the Secretary of State shall certify to all county boards of election commissioners full lists of the names of all candidates who have filed party certificates with him or her to be placed on the ballots in their respective counties at the preferential primary election.
- 7 (2) A name of a person shall not be certified and shall not be 8 placed on the ballot if prior to the certification deadline a candidate:
- 9 (A) Notifies the Secretary of State in writing, signed by
 10 the candidate and acknowledged before an officer authorized to take
 11 acknowledgements, of his or her desire to withdraw as a candidate for the
 12 office or position; or
- 13 (B) Dies.
- (b)(1) Not less than seventy (70) seventy-five (75) days before each preferential primary election, the county clerk shall certify to the county board full lists of the names of all candidates who have filed party certificates with him or her to be placed on the ballot at the preferential primary election.
- 19 (2) A name of a person shall not be certified and shall not be 20 placed on the ballot if prior to the certification deadline a candidate:
- 21 (A) Notifies the county clerk in writing, signed by the 22 candidate and acknowledged before an officer authorized to take 23 acknowledgements, of his or her desire to withdraw as a candidate for the 24 office or position; or
- 25 (B) Dies.

- (c)(1) The votes received by a person whose name appeared on the preferential primary ballot and who withdrew or died after the certification of the ballot shall be counted.
- 29 (2) If the person receives enough votes to win the nomination, a 30 vacancy in nomination shall exist.
- 31 (3) If the person receives enough votes to advance to the 32 general primary election, the person's name shall be printed on the general 33 primary election ballot.
- 34 (4) If the person receives enough votes to win the general primary election, a vacancy in nomination shall exist.
- 36 (d) When only one (1) candidate qualifies for a particular office or

position, the office or position and the name of the unopposed candidate shall be printed on the political party's ballot in all primary elections.

- (e) (1) When there are two (2) or more nominees to be selected for the same office, such as state senator, state representative, justice of the peace, alderman, or for any other office, the proper committee shall require the candidates to designate in writing a particular position, i.e., Position Number 1, Position Number 2, Position Number 3, etc., at the time that a party pledge is required to be filed with the secretary of the committee.
- 9 (2) When a candidate has once filed and designated for a certain 10 position, that candidate shall not be permitted to thereafter change the 11 position.
 - (f)(1) If at the preferential primary election for a political party a candidate receives a majority of the votes cast for that office or position, the person shall be declared the party nominee and it shall not be necessary for the candidate's name to appear on the ballot at the general primary election.
 - (2) If no candidate receives a majority of the votes cast for an office or position at the preferential primary for a political party, the names of the two (2) candidates of the political party who received the highest number of votes for an office or a position shall be placed upon the ballots at the general primary election.

- SECTION 11. Arkansas Code § 7-7-305 is amended to read as follows: 7-7-305. Printing of ballots Form <u>Draw for ballot position</u>.
- (a) The ballots of the primary election shall be provided by the county board of election commissioners. The form of the ballots shall be the same as is provided by law for ballots in general or special elections in this state. A different color ballot may be used to distinguish between political parties.
- (b) The order in which the names of the respective candidates are to appear on the ballots at all preferential and general primary elections shall be determined by lot at the public meeting of the county board of election commissioners held not later than sixty-five (65) seventy-two (72) days before the preferential primary election. The county board shall give at least ten (10) days' written notice of the time and place of the meeting to the chairs of the county committees, if the chairs are not members of the

- board, and shall, at least three (3) days before the meeting, publish notice
 of the time and place of holding the meeting in some newspaper of general
- 3 circulation in the county.

- 4 (c)(1)(A) Any person who shall file for any elective office in this 5 state may use not more than three (3) given names, one (1) of which may be a 6 nickname or any other word used for the purpose of identifying the person to 7 the voters, and may add as a prefix to his or her name the title or an 8 abbreviation of an elective public office the person currently holds.
- 9 (B) A person may only use as the prefix the title of a 10 judicial office in an election for a judgeship if the person is currently 11 serving in a judicial position to which the person has been elected.
- 12 (C) A nickname shall not include a professional or 13 honorary title.
- (2) The names and titles as proposed to be used by each candidate on the political practice pledge or, if the political practice pledge is not filed by the filing deadline, then the names and titles that appear on the party certificate shall be reviewed no later than one (1) business day after the filing deadline by the Secretary of State for state and district offices and by the county board of election commissioners for county, township, school, and municipal offices.
- 21 (3)(A) The name of every candidate shall be printed on the 22 ballot in the form as certified by either the Secretary of State or the 23 county board.
- 24 (B) However, the county board of election commissioners 25 may substitute an abbreviated title if the ballot lacks space for the title 26 requested by a candidate.
 - (C) The county board of election commissioners shall immediately notify a candidate whose requested title is abbreviated by the county board of election commissioners.
- 30 (4) A candidate shall not be permitted to change the form in 31 which his or her name will be printed on the ballot after the deadline for 32 filing the political practices pledge.

SECTION 12. Arkansas Code § 7-8-302(5)(D), concerning the submission of presidential candidates by qualified political groups, is amended to read as follows:

1 (D) No later than seventy (70) days noon on the seventyfifth day before the election, a political group that qualifies by petition to place its candidate on the ballot shall submit a certificate of choice 3 stating the names of its candidates for President and Vice President, signed under oath by either the chair, vice chair, or secretary of the political group's convention; and

8 SECTION 13. Arkansas Code § 7-9-304(c), concerning nominating 9 petitions for delegates to a constitutional convention, is amended to read as 10 follows:

The petitions shall be filed with the Secretary of State not less than seventy (70) eighty-one (81) days before the next general election, and the Secretary of State shall certify the names of all candidates and the position that each is seeking to the county board of election commissioners of the counties in the respective House districts not later than seventy (70) seventy-five (75) days prior to the date of the election. A candidate must designate the position he or she is seeking at the time he or she files his or her nominating petition with the Secretary of State, and after having designated a position, the candidate is prohibited from changing to a different position.

 - (b)(1) The State Board of Election Commissioners shall establish reasonable filing fees for nonpartisan judicial offices.
