## For An Act To Be Entitled

8 AN ACT CREATING A TWO-YEAR MORATORIUM ON THE ARKANSAS  
9 LOTTERY COMMISSION'S PLACEMENT OF *CERTAIN* SELF-  
10 SERVICE LOTTERY TICKET VENDING MACHINES IN THE STATE;  
11 AND FOR OTHER PURPOSES.

## Subtitle

14 *CREATING A TWO-YEAR MORATORIUM ON THE*  
15 *ARKANSAS LOTTERY COMMISSION'S PLACEMENT*  
16 *OF CERTAIN SELF-SERVICE LOTTERY TICKET*  
17 *VENDING MACHINES IN THE STATE.*

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 *SECTION 1. Arkansas Code § 23-115-207(a)(9), concerning the rules*  
24 *adopted by the Arkansas Lottery Commission regulating the method to be used*  
25 *in selling lottery tickets or shares, is amended to add an additional*  
26 *subdivision to read as follows:*

27 *(E)(i) Until the expiration of two (2) years from the*  
28 *effective date of this subdivision (a)(9)(E), the number of self-service*  
29 *lottery ticket vending machines deployed by the Arkansas Lottery Commission*  
30 *in this state shall not exceed one hundred (100).*

31 *(ii)(a) This subdivision (a)(9)(E) does not apply to*  
32 *a lottery retailer who:*

33 *(1) Maintains a separate customer*  
34 *service counter staffed by an employee of the retailer at all times; and*

35 *(2) Places the self-service lottery*  
36 *ticket vending machine next to or near the customer service counter.*



1 (b) As used in this subdivision (a)(9)(E),  
2 "customer service counter" means a place:

3 (1) Separate from the location where  
4 routine retail transactions occur; and

5 (2) Without limitation, where returns  
6 and exchanges of merchandise are handled, money orders are sold, and customer  
7 concerns are addressed.

8 (iii) The commission shall conduct an eighteen-month  
9 survey to determine:

10 (a) The level of any unlawful use of the self-  
11 service lottery ticket machines by minors or others; and

12 (b) Recommendations to improve security and  
13 oversight measures to assist retailers in promoting the lawful use of self-  
14 service lottery ticket vending machines.

15 (iv) By January 1, 2013, the commission shall  
16 complete the survey and submit a report to the Arkansas Lottery Commission  
17 Legislative Oversight Committee containing the:

18 (a) Results of the survey; and

19 (b) Recommendations of the commission based on  
20 the results of the survey.

21 (v) This subdivision (a)(9)(E) expires two (2) years  
22 from the date it becomes effective.
