2	SECTION 2. Arkansas Code § 17-19-301(a), regarding the premium for a		
3	bail bond, is amended to read as follows:		
4	(a) <u>(1)</u> With the exception of other provisions of this section, the		
5	premium or compensation for giving bond or depositing money or property as		
6	bail on any bond shall be ten percent (10%), except that the amount may be		
7	rounded up to the nearest five-dollar amount.		
8	(2) The bail bond agent or the bail bond company shall collect		
9	the full ten percent (10%) before the issuance of a bond.
