19	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-EIGHTH GENERAL

22	WHEREAS, Bishop Wallace Johnson was born November 19, 1935, in Calhoun
23	County, Arkansas; was one of seven (7) children born to the late Len and
24	Helen Green-Johnson; was well-respected in his community, city, and state as
25	a man of wisdom; was a pastor's pastor and an advisor for the mayor and
26	county judge; and many people came to him for his wisdom and advice in
27	personal and professional matters; and
28	
29	WHEREAS, Bishop Johnson was educated in the public schools of Ashley
30	County and Calhoun County, Arkansas, and later attended the C.H. Mason Bible
31	School and the International Theological Seminary in Atlanta, Georgia; and
32	INTEREAS Distance Islands and mounical to the levels Forme Lee College on
33 24	WHEREAS, Bishop Johnson was married to the lovely Erma Lee Golden on
34 35	May 29, 1954; their union produced four (4) children, Clarence (Charles),
35 36	Ray, Helen, and Margaret; and the Johnsons opened their home to many other families who had difficulties and who just wanted to be a part of the Johnson

WHEREAS, as a young man, Bishop Johnson had his first job when he was 3 4 twelve (12) years old, cutting pulp wood for his father; his father, Len 5 Johnson, was a self-employed contractor for his own timber company and also 6 drove a transport truck for ten (10) years; Len Johnson's influence on his 7 son was evident as Bishop Johnson later managed Williams trucking company for 8 four (4) years and eventually started several businesses of his own as an 9 entrepreneur; in 1962 he began his own trucking company and named it "E. L. 10 Johnson Trucking"; and the business flourished as Bishop Johnson became a bi-11 vocational pastor in 1984; and

13 WHEREAS, Bishop Johnson gave his life to the Lord in 1949 and was 14 called into the ministry in 1950; in 1954 he became an ordained minister 15 under the leadership of the late Bishop W.H. Kendrick; served as District 16 Superintendent from 1967-1998, as well as Chairman of the Budgeting and 17 Finance Committee and First Administrative Assistant to Bishop D.L. Lindsey; 18 and in December 1998 he was consecrated to the sacred office of Bishop and 19 installed as the Jurisdictional Prelate of the Arkansas Fourth Jurisdiction 20 by Bishop Chandler Owens, then Presiding Bishop of the Church of God in 21 Christ; and

23 WHEREAS, Bishop Johnson began his pastoral ministry with only two (2) 24 members in 1954 at the Mineral Springs Church of God in Christ in Mineral 25 Springs, Arkansas; after building the membership to fifteen (15) after only 26 one (1) year, he resigned; then became the pastor at St. Bethany Church of 27 God in Christ, in Stephens, Arkansas, from 1955-1961 and started there with 28 only fifteen (15) members and resigned with thirty (30) members; then became 29 the pastor of Velie Church of God in Christ, in Camden, Arkansas, from 1961-1978 and started with twenty (20) members and resigned with seventy-five 30 31 (75); and also pastored Willisville Church of God in Christ from 1961-1978; 32 and

33 WHEREAS, in 1978 with only twenty-one (21) members, Bishop Johnson 34 purchased the old First Assembly of God Church on Center Street in Camden, 35 Arkansas, and named the church New Calvary Church of God in Christ; the 36 church grew and many souls were blessed at this location; on July 26,1996,

the building was destroyed by fire, but the church never missed a service;
Bishop Johnson found a place to worship located at Lewis Temple Church of God
in Christ and worshiped there until the new sanctuary was completed on July
18, 1999; the name was changed to Greater New Calvary Church of God in
Christ; and the church presently has approximately five hundred (500) members
and is growing; and

8 WHEREAS, Bishop Johnson has received many awards including the Camden 9 Citizen of the Year award on September 5, 1998, and the Mayor's Award; was an 10 active member of the Camden Chamber of Commerce and the Rotary Club; and 11 served as a Board Member for CAIDC; and

WHEREAS, his parents Len and Helen Green-Johnson preceded him in death, along with two (2) brothers, one (1) sister, and a foster granddaughter; and 15

16 WHEREAS, he leaves to cherish his memories a loving and devoted wife of 17 fifty-six (56) years, Mother Erma Johnson; his children, Elder Clarence 18 Johnson and wife Rosie; Ray Johnson and wife Helen Johnson-Matheney; and 19 Margaret Johnson, all of Camden, Arkansas; foster daughter Mary Ashby of 20 North Little Rock, Arkansas; eight (8) grandchildren, Trendle, Claresha, 21 Dana, Clarence Jr., Natalie, Keith Wallace, Marcus, and Erica; three (3) 22 great-grandchildren; two (2) brothers, Hayward Johnson and wife Juanita, and 23 Lloyd Johnson, all of Camden, Arkansas; two (2) sisters, Earsie White, and 24 Sarah Beavers and husband Carter, all of Camden, Arkansas; and several 25 nieces, nephews, cousins, and friends,
