11 IMPROVEMENT FUNDS.

15 TO AMEND RULE 36(M) OF THE HOUSE OF  
16 REPRESENTATIVES OF THE EIGHTY-EIGHTH  
17 GENERAL ASSEMBLY TO ESTABLISH THE METHOD  
18 FOR THE DISTRIBUTION OF GENERAL  
19 IMPROVEMENT FUNDS.

22 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY EIGHTH GENERAL  
23 ASSEMBLY OF THE STATE OF ARKANSAS:

25 That House Rule 36(m) is amended to read as follows:

26 36.(m)(1) No appropriation bill shall be filed for introduction in  
27 either the House of Representatives or the Senate later than the fiftieth  
28 (50th) day of a regular session except upon consent of two-thirds (2/3) of  
29 the members elected to each house; and, no other bill or resolution except  
30 adjournment resolutions and resolutions requesting permission to introduce a  
31 bill or resolution shall be filed for introduction in either the House of  
32 Representatives or the Senate later than the fifty-fifth (55th) day of a  
33 regular session, except upon consent of two-thirds (2/3) of the members  
34 elected to each house. When the filing deadline for any bills or resolutions  
35 ends on Saturday or Sunday, the deadline is hereby extended until the close  
36 of business the following Monday. (J.R. 16)



1           (2)(A) General Improvement Funds allocated to the House of  
2 Representatives shall, except as provided in 36.(m)(2)(B), be divided equally  
3 between the members of the House of Representatives for each member's  
4 allocation of General Improvement Funds.

5           (B) An allocation of General Improvement Funds may be  
6 approved by the House of Representatives if the allocation is made to an  
7 agency that provides grants to entities represented in each of the one  
8 hundred (100) House of Representative districts.

9           (3) The appropriation for the allocation of General Improvement  
10 Funds shall not violate Article 5, § 24 of the Arkansas Constitution.
