20	WHEREAS, Mr. Bob Abbott, of Pine Bluff, Arkansas, was a founding member
21	of the National Kidney Foundation of Arkansas, recognizing early in life the
22	difficult if not impossible task of a family or an individual facing a
23	debilitating disease without the financial means to take the steps necessary
24	for health and survival; and
25	
26	WHEREAS, Mr. Abbott not only recognized the unfairness of attempting to
27	combat a debilitating disease without sufficient financial resources, but
28	also took numerous steps and continues to take steps today to help those in
29	need after forty (40) years of working for kidney patients; and
30	
31	WHEREAS, Mr. Abbott proposed legislation that established the Arkansas
32	Kidney Disease Commission signed into law by Governor Dale Bumpers in March,
33	1971; and
34	
35	WHEREAS, Mr. Abbott was appointed as one of the first commission
36	members of the Arkansas Kidney Disease Commission and has been reappointed by

1 every Governor since 1971. As a board member, he served in a variety of 2 roles and never lost sight of the reason why he served - to make the lives of kidney patients and their families better; and 3 4 5 WHEREAS, Mr. Abbott worked through United States Congressman Wilbur 6 Mills, who served the State of Arkansas from 1937-1977, and Dr. Ira Greifer 7 to pass significant federal legislation to combat kidney disease; and 8 9 WHEREAS, there were many times over the years in working with the 10 National Kidney Foundation of Arkansas that Mr. Abbott, through his own 11 generous support, "kept the doors open" and made sure money was available for 12 valuable financial grants for the cost of drugs, food, electricity for 13 dialysis, or other purposes; and 14 15 WHEREAS, Mr. Abbott served on the board of the Kidney House in 16 Arkansas; in 1995 received the Volunteer Service Award by the National Kidney 17 Foundation; in 2002 was the recipient of the National Kidney Foundation of 18 Arkansas Lifetime Achievement award; in 2003 was the inaugural recipient of 19 the Abilities Award from Arkansas Rehabilitation Services; in 2004 was 20 selected as a KARK Community Service Award honoree; and was most recently 21 recognized as the 2010 National Volunteer of the Year by the American 22 Association of Kidney Patients during its 37th Annual Convention, 23 24 NOW THEREFORE, 25 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-EIGHTH GENERAL 26 ASSEMBLY OF THE STATE OF ARKANSAS: 27 28 THAT the House of Representatives honors the hard work and dedication 29 of Mr. Bob Abbott on behalf of all persons who suffer from a kidney disease or disorder, and recognizes Mr. Abbott for his tireless efforts to help 30 31 kidney patients. 32 33 BE IT FURTHER RESOLVED THAT upon adoption of this resolution, a copy be 34 mailed by the Chief Clerk of the House of Representatives to Mr. Bob Abbott. 35
