20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
23 established for the Arkansas Geological Survey for the 2011-2012 fiscal year,
24 the following maximum number of regular employees.

SECTION 9. APPROPRIATION - CASH - GEOLOGY MUSEUM. There is hereby appropriated, to the Arkansas Geological Survey, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for museum expenses of the Arkansas Geological Survey - Geology Museum for the fiscal year ending June 30, 2012, the following:

SECTION 10. APPROPRIATION - LIGNITE DRILLING, TESTING, AND REPORTING. There is hereby appropriated, to the Arkansas Geological Survey, to be payable from federal funds as designated by the Chief Fiscal Officer of the State, for professional services, maintenance, general operating expenses, and matching funds for drilling and testing lignite core samples and reporting of the findings, the sum of.....\$750,000.

SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 12. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

2 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the
3 General Assembly, that the Constitution of the State of Arkansas prohibits
4 the appropriation of funds for more than a one (1) year period; that the
5 effectiveness of this Act on July 1, 2011 is essential to the operation of
6 the agency for which the appropriations in this Act are provided, and that in
7 the event of an extension of the legislative session, the delay in the
8 effective date of this Act beyond July 1, 2011 could work irreparable harm
9 upon the proper administration and provision of essential governmental
10 programs. Therefore, an emergency is hereby declared to exist and this Act
11 being necessary for the immediate preservation of the public peace, health
12 and safety shall be in full force and effect from and after July 1, 2011.
