20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Department of Rural Services for the 2011-2012 fiscal year, the following
24 maximum number of regular employees.

5 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GENERAL
 7 IMPROVEMENT PROJECTS ADMINISTRATIVE FEE. The Department of Rural Services is
 8 authorized to retain and utilize for administrative cost purposes up to one
 9 percent (1%) of the total amount of any General Improvement Fund moneys
 10 received for projects authorized for disbursement through the department by
 11 the General Assembly.

13 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
 15 TRANSFER. Upon request of the Director of the Department of Rural Services
 16 to the Chief Fiscal Officer of the State, the Chief Fiscal Officer of the
 17 State, from time to time, shall cause to be transferred on his books and
 18 those of the State Treasurer and Auditor of State, an amount not to exceed
 19 one percent (1%) from the various sub funds created in ~~the 87th Session~~
 20 ~~Projects Account of the~~ any General Improvement Fund, established for
 21 disbursement through the Department of Rural Services, to the Miscellaneous
 22 Agencies Fund Account.
 23 The funds transferred to the Miscellaneous Agencies Fund Account from the
 24 various sub funds established in ~~the 87th Session Projects Account of the~~ any
 25 General Improvement Fund pursuant to this section shall be made available and
 26 utilized solely by the Department of Rural Services for maintenance and
 27 general operations costs.

28

29 SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 31 ADMINISTRATIVE EXPENSES. Any unexpended balance of funds remaining on June
 32 30, of each fiscal year in the Miscellaneous Agencies Fund Account for the
 33 Department of Rural Services that were transferred from the various sub funds
 34 ~~of the 87th Session Projects Account of the~~ created in any General
 35 Improvement Fund for the administration of general improvement fund projects
 36 shall remain in the Miscellaneous Agencies Fund Account and made available to

1 the Department of Rural Services and utilized for the same purpose during the
2 following fiscal year.

3
4 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COUNTY
6 FAIR GRANTS. The Department of Rural Services shall develop the necessary
7 rules and regulations for the disbursement of matching fund grants to county
8 fairs for the construction, renovation and/or improvements to county fair
9 grounds. The grants shall be matched on a 50/50 basis. The match may be
10 cash or in-kind. No county fair shall receive more than \$30,000 for the
11 biennium.

12
13 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GRANT
15 AWARD CRITERIA. The Department of Rural Services shall promulgate regulations
16 establishing the criteria to be utilized in determining to whom grants will
17 be made under this Act. Subject to the approval of the Governor, and
18 approval by the Arkansas Legislative Council or the Joint Budget Committee,
19 the Department of Rural Services shall distribute the grants.
20 Determining the maximum number of employees and the maximum amount of
21 appropriation and general revenue funding for a state agency each fiscal year
22 is the prerogative of the General Assembly. This is usually accomplished by
23 delineating such maximums in the appropriation act(s) for a state agency and
24 the general revenue allocations authorized for each fund and fund account by
25 amendment to the Revenue Stabilization law. Further, the General Assembly
26 has determined that the Department of Rural Services may operate more
27 efficiently if some flexibility is provided to the Department of Rural
28 Services authorizing broad powers under this Section. Therefore, it is both
29 necessary and appropriate that the General Assembly maintain oversight by
30 requiring prior approval of the Legislative Council or Joint Budget Committee
31 as provided by this section. The requirement of approval by the Legislative
32 Council or Joint Budget Committee is not a severable part of this section.
33 If the requirement of approval by the Legislative Council or Joint Budget
34 Committee is ruled unconstitutional by a court of competent jurisdiction,
35 this entire section is void.

36 The provisions of this section shall be in effect only from July 1, ~~2010~~

1 2011 through June 30, ~~2011~~ 2012.

3 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
4 authorized by this act shall be limited to the appropriation for such agency
5 and funds made available by law for the support of such appropriations; and
6 the restrictions of the State Procurement Law, the General Accounting and
7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
8 Procedures and Restrictions Act, or their successors, and other fiscal
9 control laws of this State, where applicable, and regulations promulgated by
10 the Department of Finance and Administration, as authorized by law, shall be
11 strictly complied with in disbursement of said funds.
12

13 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General
14 Assembly that any funds disbursed under the authority of the appropriations
15 contained in this act shall be in compliance with the stated reasons for
16 which this act was adopted, as evidenced by the Agency Requests, Executive
17 Recommendations and Legislative Recommendations contained in the budget
18 manuals prepared by the Department of Finance and Administration, letters, or
19 summarized oral testimony in the official minutes of the Arkansas Legislative
20 Council or Joint Budget Committee which relate to its passage and adoption.
21

22 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
23 General Assembly, that the Constitution of the State of Arkansas prohibits
24 the appropriation of funds for more than a one (1) year period; that the
25 effectiveness of this Act on July 1, 2011 is essential to the operation of
26 the agency for which the appropriations in this Act are provided, and that in
27 the event of an extension of the legislative session, the delay in the
28 effective date of this Act beyond July 1, 2011 could work irreparable harm
29 upon the proper administration and provision of essential governmental
30 programs. Therefore, an emergency is hereby declared to exist and this Act
31 being necessary for the immediate preservation of the public peace, health
32 and safety shall be in full force and effect from and after July 1, 2011.
