coordinated care and treatment to ensure ongoing involvement and
individualized services for persons with disabilities. Every community
support program shall provide services for persons with disabilities who
reside within the respective area of the program.

8 The provisions of this section shall be in effect only from July 1, 2010
9 <u>2011</u> through June 30, 2011 <u>2012</u>.

11 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. DEVELOPMENTAL DISABILITIES - TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND 13 14 EQUIPMENT. The Division of Developmental Disabilities Services is authorized 15 to use the administrative operating accounts for capital improvements to 16 physical plants and for the purchase of capital equipment. The funds shall be 17 held by the Department of Human Services, Division of Developmental 18 Disabilities Services from the proceeds of the sale of timber that may be 19 harvested from land owned by the Division of Developmental Disabilities 20 Services. All funds deposited and all expenses shall be tracked separately. 21 The harvesting of timber is specifically authorized to provide funds to 22 finance capital improvements to the physical plants and for the purchase of 23 major capital equipment.

The Division of Developmental Disabilities Services shall report all income derived from timber management to the Chief Fiscal Officer of the State and the Arkansas Legislative Council. Any contracts initiated for the harvesting of timber shall be submitted to the Review Subcommittee of the Arkansas Legislative Council for prior review. All expenditures of funds derived from the sale of timber will be expended in accordance with relevant state purchasing laws.

The provisions of this section shall be in effect only from July 1, 2010
2011 through June 30, 2011 2012.

34 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUMAN
 36 DEVELOPMENT CENTERS AND COMMUNITY PROVIDERS.

(A) The Developmental Disabilities Services Board or the Department of
 Human Services shall not close any of the state administered Human
 Development Centers that provide therapy and residential services. which are
 located at Conway, Arkadelphia, Jonesboro, Booneville, and Warren.

5 (B) The Department of Human Services shall continue to accept clients 6 for whom it has determined that therapy and residential services are needed 7 at state administered Human Development Centers and Community Programs 8 licensed by DDS shall continue to accept clients for whom it has been 9 determined in accordance with federal law that are in need of services in the 10 community.

(C) Except for use as federal matching funds, no funds for community based services licensed by DDS shall be transferred from Grants to Community Providers line item of the Developmental Disabilities Services - Grants-in-Aid appropriation unless the transfer(s) directly <u>benefits benefit(s)</u> community based services for persons with developmental disabilities or from the appropriation for the Human Development Centers unless the transfer(s) directly <u>benefits benefit(s)</u> the Human Development Centers.

18 (D) Nor shall any general revenue funding as of March 1, 2007 July 1, 19 2011 from the Grants to Community Providers line item of the Developmental 20 Disabilities Services - Grants-in-Aid appropriation for persons with 21 developmental disabilities or from any other general revenues as of March 1, 22 2007 July 1, 2011, applied as federal matching funds for community based 23 services licensed by DDS on March 1, 2007 July 1, 2011 be reduced below the approved funding level on March 1, 2007 July 1, 2011; nor shall the general 24 25 revenues applied as federal matching funds for the Human Development Centers 26 be reduced below the approved funding level on March 1, 2007 July 1, 2011. 27

28 SECTION 16. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 29 authorized by this act shall be limited to the appropriation for such agency 30 and funds made available by law for the support of such appropriations; and 31 the restrictions of the State Procurement Law, the General Accounting and 32 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 33 Procedures and Restrictions Act, or their successors, and other fiscal 34 control laws of this State, where applicable, and regulations promulgated by 35 the Department of Finance and Administration, as authorized by law, shall be 36 strictly complied with in disbursement of said funds.

2	SECTION 17. LEGISLATIVE INTENT. It is the intent of the General
3	Assembly that any funds disbursed under the authority of the appropriations
4	contained in this act shall be in compliance with the stated reasons for
5	which this act was adopted, as evidenced by the Agency Requests, Executive
6	Recommendations and Legislative Recommendations contained in the budget
7	manuals prepared by the Department of Finance and Administration, letters, or
8	summarized oral testimony in the official minutes of the Arkansas Legislative
9	Council or Joint Budget Committee which relate to its passage and adoption.
10	
11	SECTION 18. EMERGENCY CLAUSE. It is found and determined by the
12	General Assembly, that the Constitution of the State of Arkansas prohibits
13	the appropriation of funds for more than a one (1) year period; that the
14	effectiveness of this Act on July 1, 2011 is essential to the operation of
15	the agency for which the appropriations in this Act are provided, and that in
16	the event of an extension of the legislative session, the delay in the
17	effective date of this Act beyond July 1, 2011 could work irreparable harm
18	upon the proper administration and provision of essential governmental
19	programs. Therefore, an emergency is hereby declared to exist and this Act
20	being necessary for the immediate preservation of the public peace, health
21	and safety shall be in full force and effect from and after July 1, 2011.
