 22 *SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*  
 23 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.*  
 24 *DEVELOPMENTAL DISABILITIES - GRANTS TO COMMUNITY BASED PROVIDERS. Funds*  
 25 *allocated under the appropriation for community-based services, for Grants to*  
 26 *Community Providers, in the Developmental Disabilities Services - Grants-in-*  
 27 *Aid appropriation in this act shall be used only to provide services through*  
 28 *private community based services licensed or certified by the Arkansas*  
 29 *Division of Developmental Disabilities Services (DDS). Non-profit community-*  
 30 *based programs licensed by the Division of Developmental Disabilities*  
 31 *Services are quasi-governmental instrumentalities of the state which provide*  
 32 *supports and services to individuals who have a developmental disability or*  
 33 *delay, who would otherwise require supports and services through state-*  
 34 *operated programs and facilities owned by the State of Arkansas. When DDS*  
 35 *licensed providers are involved in delivering services which are Medicaid*  
 36 *reimbursable, they must enroll as a provider with the Arkansas Medicaid*

1 Program and must bill the Arkansas Medicaid Program for all covered services  
2 for eligible individuals.

3 Services which are covered by the Arkansas State Medicaid Program or  
4 under the Alternative Community Services Waiver Program (ACS) will be  
5 utilized to the maximum extent possible for any individual who is eligible  
6 for Medicaid coverage. It is the intent of this section that DDS, as a  
7 general policy, maximize the use of Medicaid funding available for  
8 appropriate services.

9 The State shall require each provider funded from this Appropriation for  
10 community based services, including funding from the Grants/Patient Services  
11 Line, in the Developmental Disabilities Services - Operations appropriation,  
12 or from the Grants to Community Providers Line, in the Developmental  
13 Disabilities Services - Grants-in-Aid appropriation, to screen each  
14 individual to whom services are provided for a determination of eligibility  
15 or ineligibility for Medicaid coverage within thirty days of the first date  
16 that services are provided. It is the intent of this section to insure that  
17 wherever possible and appropriate, Medicaid funds are utilized for covered or  
18 waived services to individuals who are eligible for coverage under the  
19 Arkansas Medicaid Program or the ACS Waiver.

20 Nothing in this Act shall prevent the Division or any provider from  
21 extending emergency services when appropriate measures have been taken in a  
22 timely manner to secure Medicaid eligibility.

23 The provisions of this section shall be in effect only from July 1, ~~2010~~  
24 2011 through June 30, ~~2011~~ 2012.

26 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
28 DEVELOPMENTAL DISABILITIES - VOCATIONAL TRAINEES. The Division of  
29 Developmental Disabilities Services of the Department of Human Services is  
30 hereby authorized to provide employment opportunities for people with  
31 developmental disabilities residing at the Human Development Centers who work  
32 less than a competitive employment level.

33 The provisions of this section shall be in effect only from July 1, ~~2010~~  
34 2011 through June 30, ~~2011~~ 2012.

36 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GRANTS IN  
2 AID - CONDITIONS FOR RECEIVING FUNDS. Private non-profit community-based  
3 programs licensed by the Department of Human Services, Developmental  
4 Disabilities Services, are eligible to receive funds appropriated for Grants  
5 to Community Providers in the Developmental Disabilities Services - Grants-  
6 in-Aid appropriation of this Act, and as a condition of receiving such funds  
7 they shall:

8 1. Meet minimum standards of performance in the delivery of services to  
9 people with disabilities as defined by the Department of Human Services,  
10 Developmental Disabilities Services.

11 2. Supply statistical and financial data to the Department of Human  
12 Services, Developmental Disabilities Services.

13 3. Establish and maintain a sound financial management system in accordance  
14 with guidelines as set forth by the Department of Human Services.

15 4. Establish and maintain community support programs designed to provide  
16 coordinated care and treatment to ensure ongoing involvement and  
17 individualized services for persons with disabilities. Every community  
18 support program shall provide services for persons with disabilities who  
19 reside within the respective area of the program.

20 The provisions of this section shall be in effect only from July 1, ~~2010~~  
21 2011 through June 30, ~~2011~~ 2012.

23 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

25 DEVELOPMENTAL DISABILITIES – TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND  
26 EQUIPMENT. The Division of Developmental Disabilities Services is authorized  
27 to use the administrative operating accounts for capital improvements to  
28 physical plants and for the purchase of capital equipment. The funds shall be  
29 held by the Department of Human Services, Division of Developmental  
30 Disabilities Services from the proceeds of the sale of timber that may be  
31 harvested from land owned by the Division of Developmental Disabilities  
32 Services. All funds deposited and all expenses shall be tracked separately.  
33 The harvesting of timber is specifically authorized to provide funds to  
34 finance capital improvements to the physical plants and for the purchase of  
35 major capital equipment.

36 The Division of Developmental Disabilities Services shall report all

1 income derived from timber management to the Chief Fiscal Officer of the  
2 State and the Arkansas Legislative Council. Any contracts initiated for the  
3 harvesting of timber shall be submitted to the Review Subcommittee of the  
4 Arkansas Legislative Council for prior review. All expenditures of funds  
5 derived from the sale of timber will be expended in accordance with relevant  
6 state purchasing laws.

7 The provisions of this section shall be in effect only from July 1, ~~2010~~  
8 2011 through June 30, ~~2011~~ 2012.

10 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUMAN  
12 DEVELOPMENT CENTERS AND COMMUNITY PROVIDERS.

13 (A) The Developmental Disabilities Services Board or the Department of  
14 Human Services shall not close any of the state administered Human  
15 Development Centers ~~that provide therapy and residential services, which are~~  
16 located at Conway, Arkadelphia, Jonesboro, Booneville, and Warren.

17 (B) The Department of Human Services shall continue to accept clients  
18 for whom it has determined that therapy and residential services are needed  
19 at state administered Human Development Centers and Community Programs  
20 licensed by DDS shall continue to accept clients for whom it has been  
21 determined in accordance with federal law that are in need of services in the  
22 community.

23 (C) Except for use as federal matching funds, no funds for community  
24 based services licensed by DDS shall be transferred from Grants to Community  
25 Providers line item of the Developmental Disabilities Services - Grants-in-  
26 Aid appropriation unless the transfer(s) directly ~~benefits~~ benefit(s)  
27 community based services for persons with developmental disabilities or from  
28 the appropriation for the Human Development Centers unless the transfer(s)  
29 directly ~~benefits~~ benefit(s) the Human Development Centers.

30 (D) Nor shall any general revenue funding as of ~~March 1, 2007~~ July 1,  
31 2011 from the Grants to Community Providers line item of the Developmental  
32 Disabilities Services - Grants-in-Aid appropriation for persons with  
33 developmental disabilities or from any other general revenues as of ~~March 1,~~  
34 2007 July 1, 2011, applied as federal matching funds for community based  
35 services licensed by DDS on ~~March 1, 2007~~ July 1, 2011 be reduced below the  
36 approved funding level on ~~March 1, 2007~~ July 1, 2011; nor shall the general

1 revenues applied as federal matching funds for the Human Development Centers  
2 be reduced below the approved funding level on ~~March 1, 2007~~ July 1, 2011.

3  
4 *SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE*  
5 *ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.*  
6 *AUTISM TREATMENT AND COORDINATION. The Department of Human Services -*  
7 *Division of Developmental Disabilities Services shall promulgate rules and*  
8 *regulations regarding the licensure and oversight of Applied Behavior*  
9 *Analysts as described in Arkansas Code § 23-99-418. The rules and regulations*  
10 *shall include a requirement for a licensure application fee equal to that*  
11 *charged to applicants to be licensed as a psychologist as described in*  
12 *Arkansas Code § 17-97-309. Proceeds from this fee are declared as cash funds.*

13  
14 *SECTION 18. COMPLIANCE WITH OTHER LAWS.* Disbursement of funds  
15 authorized by this act shall be limited to the appropriation for such agency  
16 and funds made available by law for the support of such appropriations; and  
17 the restrictions of the State Procurement Law, the General Accounting and  
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
19 Procedures and Restrictions Act, or their successors, and other fiscal  
20 control laws of this State, where applicable, and regulations promulgated by  
21 the Department of Finance and Administration, as authorized by law, shall be  
22 strictly complied with in disbursement of said funds.

23  
24 *SECTION 19. LEGISLATIVE INTENT.* It is the intent of the General  
25 Assembly that any funds disbursed under the authority of the appropriations  
26 contained in this act shall be in compliance with the stated reasons for  
27 which this act was adopted, as evidenced by the Agency Requests, Executive  
28 Recommendations and Legislative Recommendations contained in the budget  
29 manuals prepared by the Department of Finance and Administration, letters, or  
30 summarized oral testimony in the official minutes of the Arkansas Legislative  
31 Council or Joint Budget Committee which relate to its passage and adoption.

32  
33 *SECTION 20. EMERGENCY CLAUSE.* It is found and determined by the  
34 *General Assembly, that the Constitution of the State of Arkansas prohibits*  
35 *the appropriation of funds for more than a one (1) year period; that the*  
36 *effectiveness of this Act on July 1, 2011 is essential to the operation of*

1 the agency for which the appropriations in this Act are provided, and that in  
2 the event of an extension of the legislative session, the delay in the  
3 effective date of this Act beyond July 1, 2011 could work irreparable harm  
4 upon the proper administration and provision of essential governmental  
5 programs. Therefore, an emergency is hereby declared to exist and this Act  
6 being necessary for the immediate preservation of the public peace, health  
7 and safety shall be in full force and effect from and after July 1, 2011.
