SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. AS 31 referenced in Section 3 of Act 1442 of 2009 and Section 3 of Act 1443 of 32 2009, the authorized funding for the University of Arkansas for construction 33 of an auditorium - U of A - Clinton School campus shall be deemed to also include scholarships, operations, equipment, improvements and renovations. 34 35

SECTION 24. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor

- 1 obligations otherwise incurred in relation to the project or projects
- 2 described herein in excess of the State Treasury funds actually available
- 3 therefor as provided by law. Provided, however, that institutions and
- 4 agencies listed herein shall have the authority to accept and use grants and
- 5 donations including Federal funds, and to use its unobligated cash income or
- 6 funds, or both available to it, for the purpose of supplementing the State

- 8 enumerated herein. Provided further, that the appropriations and funds

- 33 the effectiveness of this Act on July 1, 2011 is essential to the operation
- 34 of the agency for which the appropriations in this Act are provided, with the
- 35 exception that Sections 22 and 23 in this Act shall be in full force and

1	event of an extension of the legislative session, the delay in the effective
2	date of this Act beyond July 1, 2011 could work irreparable harm upon the
3	proper administration and provision of essential governmental programs, with

5	effect from and after the date of its passage and approval. Therefore, an
6	emergency is hereby declared to exist and this Act being necessary for the
7	immediate preservation of the public peace, health and safety shall be in
8	full force and effect from and after July 1, 2011, with the exception that
9	Sections 22 and 23 in this Act shall be in full force and effect from and
10	after the date of its passage and approval.
