7	session of the Eighty-Eighth General Assembly. All such acts shall have the
8	full force and effect and, so far as those acts intentionally vary from or
9	conflict with any provision contained in this act, those acts shall have the
10	effect of subsequent acts and as amending or repealing the appropriate parts
11	of the Arkansas Code of 1987.
