SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL 7 ALLOWANCES. The Board of Trustees, after seeking prior review by the 8 Arkansas Legislative Council, may approve the employment of competent 9 scientists with extraordinary research capabilities to conduct research in 10 the Biomedical Research Center established at the University of Arkansas at 11 Pine Bluff. Further, that the Board of Trustees of the University of 12 Arkansas be authorized to approve salaries for scientists up to, but not to 13 exceed, one and one-half of that portion of the Distinguished Professor line 14 item maximum authorized by the General Assembly to be paid from University of 15 Arkansas at Pine Bluff funds.

16 The provisions of this section shall be in effect only from July 1, 2010 17 <u>2011</u> through June 30, 2011 <u>2012</u>.

19 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JENKINS 21 CENTER. Of the funds appropriated in Section 3, the sum of \$252,558 for the 22 fiscal year shall be used to provide support to the Jenkins Center in Pine 23 Bluff. Any computations made by the Department of Higher Education and the Arkansas Higher Education Coordinating Board in determining levels of recommended funding for the University of Arkansas at Pine Bluff shall include 100% matching funds for the 1890 Research and

1 Extension Programs in the base.

2 3 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 4 authorized by this act shall be limited to the appropriation for such agency 5 and funds made available by law for the support of such appropriations; and 6 the restrictions of the State Procurement Law, the General Accounting and 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 8 Procedures and Restrictions Act, the Higher Education Expenditures 9 Restrictions Act, or their successors, and other fiscal control laws of this 10 State, where applicable, and regulations promulgated by the Department of 11 Finance and Administration, as authorized by law, shall be strictly complied 12 with in disbursement of said funds. 13 14 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General 15 Assembly that any funds disbursed under the authority of the appropriations 16 contained in this act shall be in compliance with the stated reasons for 17 which this act was adopted, as evidenced by the Agency Requests, Executive 18 Recommendations and Legislative Recommendations contained in the budget 19 manuals prepared by the Department of Finance and Administration, letters, or 20 summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. 21 22 23 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits 24 25 the appropriation of funds for more than a one (1) year period; that the 26 effectiveness of this Act on July 1, 2011 is essential to the operation of 27 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 28 effective date of this Act beyond July 1, 2011 could work irreparable harm 29 30 upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act 31 32 being necessary for the immediate preservation of the public peace, health 33 and safety shall be in full force and effect from and after July 1, 2011. 34 35 /s/Joint Budget Committee 36
