SECTION 11. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 13 14 authorized by this act shall be limited to the appropriation for such agency 15 and funds made available by law for the support of such appropriations; and 16 the restrictions of the State Procurement Law, the General Accounting and 17 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 18 Procedures and Restrictions Act, the Higher Education Expenditures 19 Restrictions Act, or their successors, and other fiscal control laws of this 20 State, where applicable, and regulations promulgated by the Department of 21 Finance and Administration, as authorized by law, shall be strictly complied 22 with in disbursement of said funds.

24 SECTION 12. LEGISLATIVE INTENT.
