2	vehicle and can include more than one (1) person but not more than three (3)

4	(B) "Owner" does not include a business, firm,
5	partnership, corporation, association, or any other legally-created entity;

7	(4) "Vehicle" means a motorized or nonmotorized piece of
8	equipment with wheels that is:
