1	SECTION 2. Arkansas Code § 27-24-1005(b)(2), regarding issuance,
2	renewal, and replacement of special license plates issued for colleges and
3	universities, is amended to read as follows:
4	(2) A fee not to exceed twenty-five dollars (\$25.00) to cover
5	the design-use contribution by the college or university or the Arkansas
6	School for the Deaf or for fund-raising purposes; and
7	
8	SECTION 3. Arkansas Code § 27-24-1005(e), regarding issuance, renewal,
9	and replacement of special license plates issued for colleges and
10	universities, is amended to read as follows:
11	(e)(1) The department shall remit the fees collected under subdivision
12	(b)(2) of this section on a monthly basis to the college or university or the
13	Arkansas School for the Deaf depending on the school for which each special
14	license plate was purchased.
15	(2) The department shall also provide to each participating
16	college or university <u>or the Arkansas School for the Deaf</u> a list of persons
17	who have paid for a special license plate under this subchapter <u>relating to</u>
18	that entity.

20	SECTION 4. Arkansas Code Title 27, Chapter 24, Subchapter 10 is
21	amended to add an additional section to read as follows:
22	27-24-1010. Arkansas School for the Deaf.
23	(a) The Director of the Department of Finance and Administration shall
24	issue a special license plate for the Arkansas School for the Deaf in the
25	manner and subject to the conditions provided under this subchapter.
26	(b) The special Arkansas School for the Deaf motor vehicle license
27	plate shall:
28	(1) Be designed by the Department of Finance and Administration
29	in consultation with the Board of Trustees of the Arkansas School for the
30	Blind and Arkansas School for the Deaf;
31	(2) Contain the words "Arkansas School for the Deaf" and a
32	picture showing the sign language hand shape for "I Love You"; and
33	(3) Be numbered consecutively.
34	(c) The director shall determine the amount of the costs for the
35	issuance of the special license plate under this section as follows:
36	(1) The fee for the cost of initial orders of the new design

2	(2) The number of applications that must be received to cover

7	(d) The Department of Finance and Administration shall issue a special		
8	license plate under this section upon payment of:		
9	(1) The fee required by law for registration of the motor		
10	vehicle;		
11	(2)(A) Twenty-five dollars (\$25.00) to cover the design-use		
12	contribution.		
13	(B) The design-use contribution shall be remitted monthly		
14	to the Arkansas School for the Deaf Foundation to be used for foundation		
15	purposes; and		
16	(3)(A) A handling and administrative fee of ten dollars		
17	<u>(\$10.00).</u>		
18	(B) The handling and administrative fee shall be:		
19	(i) Deposited into the State Central Services Fund		
20	for the benefit of the Revenue Division of the Department of Finance and		
21	Administration; and		
22	(ii) Credited to the division as supplemental and in		
23	addition to all other funds that may be deposited for the benefit of the		
24	division.		
25	(C) The handling and administrative fee shall not be		
26	considered or credited to the division as direct revenue.		
27	(e)(1) A special license plate issued under this section may be		
28	renewed annually or replaced under the procedures set out in § 27-24-1005.		
29	(2) However, the division shall remit the fees collected under §

33	SECTION 5. DO NOT CODIFY.		
34	(a) Within thirty (30) days after the effective date of this act, the		
35	Director of the Department of Finance and Administration shall notify the		
36	Board of Trustees of the Arkansas School for the Blind and Arkansas School

3	(b) The Arkansas School for the Deaf Foundation shall submit to the
4	director an application that includes the following:
5	(1) A statement that the Arkansas School for the Deaf Foundation
6	<u>is:</u>
7	(i) A nonprofit organization that has been approved for
8	tax exempt status under Section 501(c)(3) of the Internal Revenue Code, as in
9	effect on January 1, 2011;
10	(ii) Based, headquartered, or has a chapter in Arkansas;
11	<u>and</u>
12	(iii) For social, civic, entertainment, or other purposes;
13	(2) A statement that the Arkansas School for the Deaf Foundation
14	<pre>is not:</pre>
15	(i) A political party;
16	(ii) Created primarily to promote a specific political
17	belief; and
18	(iii) Promoting any specific religion, faith, or anti-
19	religion as its primary purpose;
20	(3) The foundation's financial plan for the design-use
21	contribution from the special license plate that specifies the charitable use
22	for the proceeds; and
23	(4) An affidavit signed by an official of the foundation that
24	states that the proceeds from the special license plate will be used
25	according to the financial plan submitted with the application.
26	(c) The Arkansas School for the Deaf Foundation shall submit the
27	information required under subsection (b) of this section within one hundred
28	twenty (120) days after the effective date of this act.
