17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 *SECTION 1. Arkansas Code § 16-12-201 is amended to read as follows:*  
20 *16-12-201. Court of Appeals – Districts.*

21 *The State of Arkansas is divided into the following seven (7) districts*  
22 *for the election of judges to the Court of Appeals:*

23 *(1) District 1 shall be composed of Clay, Craighead, Crittenden,*  
24 *Cross, Greene, Lawrence, Lonoke, Mississippi, Monroe, Poinsett, Prairie,*  
25 *Randolph, White, and Woodruff counties;*

26 *(2) District 2 shall be composed of Baxter, Boone, Carroll,*  
27 *Cleburne, Conway, Faulkner, Fulton, Independence, Izard, Jackson, ~~Lawrence~~,*  
28 *Marion, Newton, Pope, ~~Randolph~~, Searcy, Sharp, Stone, and Van Buren counties;*

29 *(3) District 3 shall be composed of Benton, ~~Carroll~~, Crawford,*  
30 *~~Franklin~~, ~~Johnson~~, ~~Madison~~, and Washington counties;*

31 *(4) District 4 shall be composed of ~~Clark~~, Franklin, Garland,*  
32 *Hempstead, Hot Spring, Howard, Johnson, Little River, Logan, Madison, Miller,*  
33 *Montgomery, Pike, Polk, Scott, Sebastian, Sevier, and Yell counties;*

34 *(5) District 5 shall be composed of Ashley, Bradley, Calhoun,*  
35 *Clark, Cleveland, Columbia, Dallas, Drew, Grant, Lafayette, Lincoln, Nevada,*  
36 *Ouachita, and Union counties;*



1                   (6) *District 6 shall be composed of Pulaski, Perry, and Saline*  
2 *counties; and*

3                   (7) *District 7 shall be composed of Arkansas, Chicot, Desha,*  
4 *Jefferson, Lee, Phillips, and St. Francis counties.*
