17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 *SECTION 1. Arkansas Code § 16-12-201 is amended to read as follows:*  
20 *16-12-201. Court of Appeals – Districts.*

21 *The State of Arkansas is divided into the following seven (7) districts*  
22 *for the election of judges to the Court of Appeals:*

23 *(1) District 1 shall be composed of:*

24 *(A) Clay, Craighead, Crittenden, Cross, Greene, Lawrence,*  
25 *Lonoke, ~~Mississippi~~, Monroe, Poinsett, Prairie, Randolph, White, and Woodruff*  
26 *counties; and*

27 *(B) The portions of Crittenden County and Mississippi*  
28 *County that are not a part of subdistrict 2.1 that was created under Hunt v.*  
29 *State of Arkansas, consent decree # PB-C-89-406;*

30 *(2) District 2 shall be composed of Baxter, Boone, Carroll,*  
31 *Cleburne, Conway, Faulkner, Fulton, Independence, Izard, Jackson, ~~Lawrence,~~*  
32 *Marion, Newton, Pope, ~~Randolph~~, Searcy, Sharp, Stone, and Van Buren counties;*

33 *(3) District 3 shall be composed of Benton, ~~Carroll~~, Crawford,*  
34 *~~Franklin, Johnson, Madison,~~ and Washington counties;*

35 *(4) District 4 shall be composed of ~~Clark~~, Franklin, Garland,*  
36 *Hempstead, Hot Spring, Howard, Johnson, Little River, Logan, Madison, Miller,*



1 *Montgomery, ~~Pike~~, Polk, Scott, Sebastian, Sevier, and Yell counties;*

2 *(5) District 5 shall be composed of Ashley, Bradley, Calhoun,*  
3 *Clark, Cleveland, Columbia, Dallas, Drew, Grant, Lafayette, Lincoln, Nevada,*  
4 *Ouachita, Pike, and Union counties;*

5 *(6) District 6 shall be composed of Pulaski, Perry, and Saline*  
6 *counties; and*

7 *(7) District 7 shall be composed of:*

8 *(A) Arkansas, Chicot, Desha, Jefferson, Lee, Phillips, and*  
9 *St. Francis counties; and*

10 *(B) The portions of Crittenden County and Mississippi*  
11 *County that are a part of subdistrict 2.1 that was created under Hunt v.*  
12 *State of Arkansas, consent decree # PB-C-89-406.*
