2	this section is the fee required by law for the registration and licensing o		
3	the motor vehicle and an additional fee of five dollars (\$5.00) to be		
4	remitted monthly to the Arkansas Fallen Firefighters Memorial Board.		
5	(4) The replacement fee for a special license plate decal issue		
6	under this section is ten dollars (\$10.00).

8	SECTION 2. Arkansas Code § 27-24-1311(c), regarding the special		
9	license plate for firefighters, is amended to read as follows:		
10	(c)(l) A professional firefighter may apply for and annually renew a		
11	special license plate issued under this section.		
12	(2) The fee for the initial application for a special license		
13	plate under this section is:		
14	(A) The fee required by law for the registration and		
15	licensing of the motor vehicle;		
16	(B) A handling and administrative fee in the amount of ten		
17	dollars (\$10.00); and		
18	(C) An additional fee of one dollar (\$1.00) five dollars		
19	(\$5.00) to be deposited into the Fallen Firefighters' Memorial Fund remitted		
20	monthly to the Arkansas Fallen Firefighters Memorial Board.		
21	(3) The fee for the renewal of a special license plate under		
22	this section is the fee required by law for the registration and licensing of		
23	the motor vehicle and an additional fee of one dollar (\$1.00) five dollars		
24	(\$5.00) to be deposited into the Fallen Firefighters' Memorial Fund remitted		
25	monthly to the Arkansas Fallen Firefighters Memorial Board.

27	SECTION 3. DO NOT CODIFY.		
28	(a) The Arkansas Fallen Firefighters Memorial Board shall submit to		
29	the director an application that includes the following:		
30	(1) A statement that the Arkansas Fallen Firefighters Memorial		
31	Board is:		
32	(i) A nonprofit organization that has been approved for		
33	tax exempt status under Section 501(c)(3) of the Internal Revenue Code, as i		
34	effect on January 1, 2011;		
35	(ii) Based, headquartered, or has a chapter in Arkansas;

2	(2) A statement that the Arkansas Fallen Firefighters Memorial
3	Board is not:
4	(i) A political party;
5	(ii) Created primarily to promote a specific political
6	belief; and
7	(iii) Promoting any specific religion, faith, or anti-
8	religion as its primary purpose;
9	(3) The Arkansas Fallen Firefighters Memorial Board's financial
10	plan for the funds received from the special license plate under this act
11	that specifies the charitable use for the proceeds; and
12	(4) An affidavit signed by an official of the Arkansas Fallen
13	Firefighters Memorial Board that states that the proceeds from the special
14	license plate will be used according to the financial plan submitted with the
15	application.
16	(c) The Arkansas Fallen Firefighters Memorial Board shall submit the
17	information required under subsection (b) of this section within one hundred
18	twenty (120) days after the effective date of this act.
19	(d) The Arkansas Fallen Firefighters Memorial Board may submit the
20	documentation required under this act along with its submission related to
21	the design-use contribution fee under § 27-15-5201 et seq.
