28	<u>(a) As used in</u>	n this section:		
29	(1) "Child maltreatment" means the abuse, sexual abuse, neglect			
30	sexual exploitation, or abandonment of a child under the Child Maltreatment			
31	Act, § 12-18-101 et seq.; and			
32	<u>(2) "Lic</u>	censed school personnel" means a	<u>person who works with</u>	
33	students in an elemen	students in an elementary or secondary public school, a public charter		
34	school, a school district, or an education service cooperative for whom a			
35	license issued by the State Board of Education is a condition of employment,			
36	including without lin	mitation a:		

1	(A) School or school district administrator;		
2	(B) Teacher;		
3	(C) Coach for a school athletics program;		
4	(D) School counselor;		
5	(E) School social worker;		
6	(F) School psychologist; and		
7	(G) School nurse.		
8	(b) For each degree program at an institution of higher learning		
9	education in this state that is a prerequisite for licensure or certification
