3	(b)(1) Notwithstanding the residence requirements of § 6-18-202, the		
4	parent of a military dependent who resides with the military dependent on a		
5	military base may choose a school district and school where the military		
6	dependent will attend school that is other than the resident school district		
7	or the school regularly assigned by the resident school district.		
8	(2) A school choice made under this section is not subject to		
9	any other Arkansas school choice or school transfer law including without		
10	<u>limitation the:</u>		
11	(A) Arkansas Public School Choice Act of 1989, § 6-18-206;		
12	(B) Arkansas Opportunity Public School Choice Act of 2004,		
13	§ 6-18-227; and		
14	(C) Prohibition on transfers under § 6-18-317.		
15	(c) The school district chosen by a parent under this section has the		
16	legal responsibility for the education of the military dependent.		
17	(d) The military dependent is counted as a part of the average daily		
18	membership of the school district where the military dependent attends		
19	school.		
20	(e) The responsibility for transportation of the military dependent to		
21	and from the chosen school is:		
22	(1) Borne by the parent; or		
23	(2)(A) As agreed in writing between the parent and the school		
24	district where the military dependent attends school.		
25	(B) The Department of Education shall approve any		
26	agreement for a nonresident school district to transport the military		
27	dependent to and from a school in a nonresident school district.		
28	(f) The State Board of Education may promulgate rules for the		
29	administration of this section.
